Special Commission of Inquiry into LGBTIQ hate crimes

I refer to your letter to the Commissioner, the Honourable Justice John Sackar, of 18 October 2022.

The Inquiry

As you are aware, on 13 April 2022 the Governor of NSW, by Letters Patent, authorised the Commissioner to inquire into and report on all unsolved LGBTIQ hate crime deaths in the 40 years between 1970 and 2010. Specifically, the Letters Patent require the Commissioner to inquire into, report and make recommendations on the following matters:

- A. "The manner and cause of death in all cases that remain unsolved from the 88 deaths or suspected deaths of men potentially motivated by gay hate bias that were considered by Strike Force Parrabell; and
- B. The manner and cause of death in all unsolved suspected hate crime deaths in New South Wales that occurred between 1970 and 2010 where:
 - i. The victim was a member of the lesbian, gay, bisexual, transgender, intersex and queer (LGBTIQ) community; and
 - ii. The death was the subject of a previous investigation by the NSW Police Force."

As is clear, the Commissioner is required to carry out his own inquiry, including by investigation where appropriate, into all of those deaths, and not merely to review the existing documentation. The total number of deaths falling within those two categories, A and B, is still being assessed but is likely to be 40 or more.

In conducting the Inquiry, the Commissioner is also expressly directed to have regard to the reports and findings of previous inquiries and reports, including, *inter alia*, the final report of Strike Force Parrabell.

As you know, the Commissioner is required to deliver his report, having assembled all relevant information and carried out all necessary inquiries and investigations, by 30 June 2023.

Sources of information about the deaths

Obviously the primary source of information, in relation to every one of the historical deaths falling within both Category A and category B, is the material held by the NSW Police Force (NSWPF). It is the NSWPF that investigated the deaths (sometimes once, sometimes more than once), created and/or gathered all the records relating to the deaths and the investigations, and retains control of that material.

The Inquiry is also making every attempt to locate relevant records by other means, including through requests to the Coroners Court of NSW (and other courts in the cases of matters where criminal charges have been laid), as well as summonses issued to the Office of the Director of Public Prosecutions, NSW Health Pathology and other sources.

The Inquiry has to date issued 32 summonses to produce to the NSWPF (as at 21 October 2022). In respect of many of the summonses, production by the NSWPF has been late and/or incomplete. Often no extension of time was sought. On some but not all occasions the NSWPF advised, on or about the last day for production, that it would not be able to comply. Ultimately the Inquiry was obliged to write to the NSWPF about these problems, by its letter of 8 September 2022. Since then, the performance of the NSWPF has improved in that regard.

The table below provides a chronology of each summons, noting the many occasions upon which the NSWPF has not complied with the due date for production of material or has been granted extensions of time to produce material.

The Inquiry is currently reviewing the material recently provided by the NSWPF (with respect to summons NSWPF12 in particular and more generally) and will advise if there is any identifiable material which appears not to have been produced or has been provided in a way that is inaccessible.

Production of material

The Commissioner is very concerned about the delays by the NSWPF in producing material, and about the manner in which material has been and is still being produced, particularly given the limited timeframe he has to deliver his final report.

The mode of production of material by the NSWPF to date is not satisfactory. Among other things:

- □ Hardcopy material has been provided without any schedule or covering letter outlining the material produced.
- □ At times, material produced electronically has been transferred without a clear indication of the item number of the summons to which the material is responsive.
- Emails have also been produced without attachments at all, or with attachments provided separately.
- □ Hyperlinks contained within documents have been unable to be accessed.

It is requested that for all future productions, all material (including hardcopy material) should be provided with a detailed covering letter or email outlining the following:

- 1. Whether the material represents complete or partial production (including, when material is produced in tranches, whether there are further tranches to be produced);
- 2. A clear cross-referencing of the item number and summons to which the material is responsive; and
- 3. An account of the searches undertaken by the NSWPF to locate information, where items sought pursuant to the summons are unable to be produced.

All electronic material should also be produced in its native format and material non-responsive to the summons should be removed from bundles provided by your instructing officers prior to production.

I will be writing to you again shortly with some further information regarding electronic production to ensure the material is compatible with the electronic court processes utilised by the Inquiry.

NSWPF resourcing

I note that the NSWFP retained senior and junior counsel at a very early stage, and that the Commissioner and Senior Counsel Assisting the Inquiry, Peter Gray SC, met with Mr Tedeschi KC in the initial months following the establishment of the Inquiry.

As you will recall, at the private hearing of the Inquiry on 6 and 7 June 2022, the Commissioner raised with Mr Mykkelveldt, junior counsel for the NSWPF, the need to identify the deaths falling within Category B of the Inquiry's terms of reference, as well as any deaths the subject of active current review or investigation, in an expedient manner.

Mr Mykkelveldt informed the Commissioner (from the bar table) that three officers of the UHT had been allocated to the task of preparing case summaries for the deaths

within the relevant period on the Tracking File. Mr Mykkelveldt said that a great deal of work was already being done on this task and that the summaries would be provided to the Inquiry the following week. His Honour indicated that he was prepared to allow the NSWPF two to three weeks to complete the summaries.

On 10 June 2022, the Inquiry wrote to the NSWPF to formalise the requests for information and documents which had arisen in the course of the private hearing, taking into account the indications and assurances given by **Exercise** and Mr Mykkelveldt, and asked that the information and documents be provided by 22 June 2022. That did not occur.

On 7 July 2022, the Inquiry wrote to the NSWPF to follow up the requests for information and documents referred to above, much of which still remained outstanding. The Inquiry reduced the scope of what was being sought.

Finally, on 18 July 2022, the NSWPF replied to the Inquiry's 10 June letter. That reply included the following:

"It has not been possible to make provision for full-time designated police resources to respond to the requisitions of the Inquiry. We suggest that the exercise of preparing short form case summaries should be undertaken by the team assisting the Inquiry. The Commissioner of Police has not received any funding or additional resources in relation to the Inquiry. Many of the case files for the "undetected" deaths are voluminous. While it is acknowledged that your letter of 7 July 2022 substantially reduces the scope of the work requested, the preparation of summaries in respect of the remaining deaths would likely be a substantial undertaking. In order to complete this task, it may be necessary for the Commissioner to re-allocate significant resources away from ongoing active investigations by the UHT. The precise scope of the task will depend on the amount of material in each of the relevant files. Even accounting for the recent reduction in its scope, the task is likely to be a demanding one."

In other words, the NSWPF now effectively said, in late July, that it would not be able to do what it had expressly indicated in early June it would do, and proposed that the Inquiry do the relevant sifting of material itself.

Similar concerns in relation to resourcing were outlined by the NSWPF in an email to James Herrington dated 29 July 2022 in response to a request for information regarding long term missing persons.

The Commissioner notes the contents of paragraphs [4] - [7] of your letter in relation to resourcing. However, it is entirely a matter for the Commissioner of NSWPF to determine how resources are deployed within the NSWPF, and whether additional resources are needed, and to make any request to the relevant Minister for additional funding if that is necessary. As is apparent from the correspondence referred to above, the need for adequate NSWPF resourcing in connection with the Inquiry has been obvious to the NSWPF for many months.

Paragraph 6 of your letter

In paragraph [6] of your letter, you appear to assert that the entirely proper requirements on the part of the Inquiry, that necessary documents be produced to it by the NSWPF, is the cause of live investigations and reviews by the UHT being "stalled".

Any such allegation is completely inappropriate, is flatly rejected, and should be withdrawn. If any such impact on the work of the UHT has occurred, that is entirely attributable to resourcing decisions taken, or not taken, by the NSWPF.

The Inquiry which the Commissioner is conducting is one which has been instituted by the Government of NSW, following recommendations made by a Standing Committee of the NSW Parliament. The relevant legislation specifically provides powers to issue summonses for the production of documents. By reason of the large number of deaths or suspected deaths, and the unique position of the NSWPF in relation to the holding of records relating to those deaths, it is and always was inevitable that a large amount of material will be called for from the NSWPF. I note that the NSWPF has at no stage objected to the production of any material, or advanced any suggestion that the material sought was not properly calledfor.

Further investigations by the Inquiry

The Inquiry is of the utmost importance to the Parliament and Government of NSW, and to the community. The Commissioner will continue to pursue all proper avenues of investigation with respect to the deaths of persons falling within the Inquiry's terms of reference.

Accordingly, in response to paragraphs [1], [8] and [9], the NSWPF should proceed on the basis that the Commissioner will issue any summons he considers necessary and appropriate, both to advance his inquiry into the relevant deaths, and to discharge the obligation cast upon him by the Inquiry's terms of reference to "have regard to" previous inquiries and reports, including the final report of Strike Force Parrabell.
