Project Brief

Undertake an independent process and outcome evaluation of Strikeforce Parabell's review of the deaths of 88 people (1979 and 2000) that are connected with the LGBTI community

Aims & Objectives¹

Phase 1

- Historiography of policing hate crime in NSW; NSWPF policies and approaches at the time of these deaths (SOPs etc); previous reviews and enquiries (including the Tomsen & Thompson reviews/publications)
- 2) Evaluate the process and instruments used to undertake the Parabell evaluation
 - a) Why these cases, and what role has the selection criteria led to case exclusion?
 - Assessed against what criteria? Relevance of criteria to NSW law and NSWPF
 SOPs
 - c) Evaluate the role and process of community engagement
- 3) Review the 88 Parabell reports in relation to the historic policing practices, including reporting mechanisms [Possibly use the process tools used by UK hate crime scrutiny panels]

Phase 2

- Review the 88 Parabell reports against FBI hate crime assessment tool, with triangulation against a second hate crime assessment tool (possibly London MPS)
- 2) Review original source materials, where required
- 3) Assess historic and Parabell determinations (including changes in determinations) in relation to the selection criteria
- 4) Provide an independent evaluation report
 - a) Identify critical outcomes and determinations in these historic cases that affect existing policies, practices, SOPs, and police training
 - b) Provide evidence for further community engagement

Ethics

As the researchers may be accessing identifiable information and undertaking informant interviews with key stakeholders, an ethics protocol (low risk) will be necessary, along with a confidentiality agreement with NSWPF (especially with regard to the source material).

Vicarious trauma; this is very low risk given the experience of the consultants (see attached CVs) but will need to be addressed
