RECITALS:

- A. The Principal and the Supplier entered into a Contract – **Strikeforce Parrabell Project 001286** dated **5th October 2016**.
- B. The Original Contract was varied by Deed on 21 March 2017 ("First Variation") attached hereto as Appendix B.
- C. The Principal and the Supplier now wish to further vary the Original Contract in accordance with the terms of this Deed to allow an additional \$5000 payment based on a variation request from Associate Professor Derek Dalton dated 24th July 2017 (refer to Appendix A).

"Original Contract" means the Contract Deed **Strikeforce Parrabell Project 001286** dated **5th October 2016** between the Principal and the Supplier.

- 2.2** Where there is any inconsistency between this Deed and the Original Contract, this Deed shall prevail.
