I have attached two recent briefs we did in response to Alex's questions about Operation Parrabell as well as the Bias Crimes Assessment of the North Head Beat. Nothing is happening with Parrabell at present, which is something Alex will not like to hear.

We have a spreadsheet of all the names on the list for 1976 - 2000 - 91 names and the statistics in Nathan's brief refer to what we have on those potential 91 names - more than half of these have been solved (about 56) and criminal charges laid. To date the research indicates about 11 homicides may have a possible gay hate motive. Of the 91, Parrabell was only going to include those within Sydney so about 11 of them were excluded from the scope.

I have also attached a brief from Unsolved Homicide Team from about September 2013 which refers to 30 of the names from former NSWPF employee Sue Thompson's list of names and their assessment on these as being gay hate crimes.


