Hi Tony, Shobha

We (Shyuan and I) are finalising the procurement documents and should have them ready for you to approve today. One concern we both share is the short timeframe if we aim for November completion. Given the scope, we were thinking 6 months.

I also spoke with ACON last week, as suggested in the last Parrabell meeting. They have been compiling a 'dossier' of alleged gay hate crimes during that period and we did talk to them a while back about collaborating at some point. I spoke with Shannon and asked her for a list of cases they are working on - just to make sure we haven't missed any - and briefed her on our intentions regarding procuring an independent research team to work with us in the final stages of Parrabell. I also asked whether she could comment or add to our brief for the research team, again just to make sure we address any community concerns that we can, and may not know about.

**Is it ok to send her the same briefing points I sent out to the proposed researchers to give her an idea of what we are asking for?**

Also, we talked about the next Parrabell update meeting and though maybe when the researchers come on board we could hold another meeting with our key stakeholders to give them an opportunity to meet the researchers and hear first hand how they will be conducting their part of the project.
