Below are the dot points we have sent out regarding the tender. We have changed our thinking a little and now want the researcher/s to be involved prior to completing the Parrabell review and conduct the last stage as a collaborative process if that makes sense. Not sure exactly how it will work but we thought we should have them start looking at cases and determinations, provide comments which may influence our final conclusions.

- An independent evaluation of Strikeforce Parabell's (SP) review of the identified 88 deaths during the late 70s, 80s and 90s we have a number of 86 deaths with 4 other possible names to include plus one person from 2007. I've attached the list here FYI. It would be great if we can all be on the same page as far as the list goes. Is there any chance we can compare our lists?
- · An examination of the process and method used to conduct SP including the application of NSWPF Bias Crime indicators great
- · Access and review original source materials as needed great
- Research and provide an introductory section detailing the historical context of policing during this period and a commentary on investigating deaths of men identified as gay or transgender during this period We would be really keen to assist with this where we can and we could provide information that is relevant to the context of the time (community reports, community vibe etc)
- · Provide a conclusion including comment on the efficacy and quality of SP's review, the outcomes of the review, does the researcher agree with SP outcomes/determinations? great
- Provide recommendations for future policing, community engagement, training, development of bias crime indicators/processes great, we could help with this as well
- Provide relevant recommendations for future directions of the GLLO program will recommendations about GLLO come out of SP I wonder?
- Produce and publish a research article great we'd be keen to contribute where possible and appropriate.
- Throughout this entire process maintain close contact with the Corporate Sponsor Sexuality & Gender Diversity and the Senior Programs Officer (S&GD) awesome

Could they provide input into how to feed this information back to relevant community members and community in general – as we mentioned sometimes it isn't the jurisdiction of the police but rather the court systems - this could be pointed to by the researchers among other things.

Let me know your thoughts about the parameters outlined above and whether there are ley things we have missed I checked with Tony and this week's meeting on Thursday is just a regular one, no Parrabell update this time. We will probably wait until the researcher/s are on board and hold a meeting then.
