Having said that, after speaking with Mr Crandell today I am happy to send you the completed review

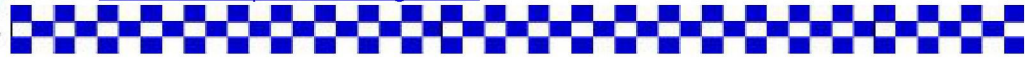
forms for your information.
