Product Type: TEXT DOCUMENTS: Statement Completed Date: 20 Aug 2001 **Brief Description:** On the 20/08/2001, the statement of Detecive BIGNELL was received at operation TARADALE. The statement is dated the 17/08/2001 and details Detective BIGNELL's involvement in the investigation in gay related homicides within the Eastern Suburbs area. Detective BIGNELL was a member of the Homicide Unit, Major Crime South at this time. See statement summary for further details. Summary: Para 3: In making the statement Detective BIGNELL makes reference to nineteen documents (19), these are described as annexures 1 to 19. In making his statement he did not have access to any duty book or notebooks covering the period of time Para 4: as they are unavailable. Para 6: On 28/10/1990, commenced duty with Homicide Unit, Major Crime South. His work partner at the time was Det Sgt McCANN. Was involved in brief preparation relating to the murders of Richard Norman JOHNSON at Alexandria on 24/01/1990 and Kritchikorn RATTANAJURATHAPORN at McKenzies Point Bondi on 20/07/1990. Para 7: During the investigation into the death of a homosexual victim, Ludwig Johann GERTSCH at Paddington, the inquiry was expanded after the investigation identified other incidents involving other homosexual males committed by groups of youths in Bondi and Alexandria. The youths targeted two parks frequented by homosexuals in the area, these area's are commonly known as being 'beats'. Para 8: No link was establish between the murder of GERTSCH and the incidents involving the groups of youths targeting homosexual males in Bondi and Alexandria. Para 9: The inquiries indicated above indicated possible links between incidents involving: the murder of William ALLEN at Alexandria on 28/12/1988, the suspicious death of John RUSSELL at South Bondi on 24/11/1989, the assualt upon David McMAHON at Bondi on 21/12/1989, the murder of Wayne TONKS at Artarmon on 19/05/1990. disappearance of Ross WARREN from South Bondi on 21/07/1989. Para 10: On 08/04/1991, prepared a listening devices affidavit to record the conversation between NP18 NP21 was assisting police in this process, who had previously had conversations with NP19 The LD application was in relation to the murder of ALLEN. Produces annexure 6 into evidence relating to this paragraph. Para 11: The listening device was used pursuant to the warrant between 1.28pm & 3.08pm on 11/04/1991 at the Minda Detention Centre recording the conversation between NP21 and NP18 Insufficient evidence was obtained for the arrest of any person. Produces annexure 20 into evidence relating to this paragraph. On the 15/04/1991, prepared a listening device affidavit to obtain a warrant to further investigate the murders of a number of homosexual me in Sydney and to listen and record private conversations between NP21 NP19 NP15 and NP18 Produces annexure 8 into evidence relating to this paragraph. Para 13: The listening device was used pursuant to the warrant between 10am and 1.30pm on 24/04/1991 at the Minda Detention Centre to record those persons stated in paragraph 12. Insufficient evidence was obtained for the arrest of any person. Produces annexure 21 into evidence relating to this paragraph. Para 14: On the 15/04/1991 assisted Det Sgt McCANN prepare a report on victims of homosexual crime in the Alexandria and South Bondi areas'. Produces annexure 9 into evidence relating to this paragraph.

On the 19/04/1991, interviewed and obtained a statement from Miss M who states that she had a conversation with NP57 who bragged of an involvement in the murder of Ross WARREN.

with NP57 who bragged to her about being in a group of eight who had thrown Ross WARREN

Para 16: On the 24/04/1991, interviewed and obtained Miss X who states that she had a conversation

off the rocks.

- Para 17: On 03/07/1991, assisted Det Sgt McCANN in preparing an affidavit for the use of listening devices to be used to gain further evidence relating to homosexual crimes committed by a group of juveniles in the Alexandria and Bondi areas'. The LD was to record conversations between NP21 and NP16 at Minda Detention Centre. Produces annexure 13 into evidence relating to this paragraph.
- Para 18: The LD warrant was used on three occasions in July 1991 at the Minda Detention Centre recording conversations between NP21 and NP16 including NP16 involvement in a number of assaults upon homosexual men in Alexandria and Bondi. Insufficient evidence was obtained for the arrest of any person as the exact time, date and location could not be established. Produces annexure 21 into evidence relating to this paragraph.
- Para 19: On 10/08/1991, again assisted Det Sgt McCANN prepare an overview report entitled, 'Over view of homosexual murders and incidents within the inner city area inner city gay murders.' Was aware of the accuracy of the information it contained. Produces annexure 18 into evidence relating to this paragraph.
- Para 20: The investigation was suspended due to absence of admissible evidence to support criminal charges against any individual or group of individuals. The investigation established that members of homosexual community had been the subjected to serious assaults by predatory groups of juveniles. The recorded conversations and intelligence indicated that the group were prolific in their violent offences against homosexuals between December 1988 to July 1990 in these areas although many such incidents remained unreported to police.

- 6. On 28 October, 1990 I was transferred and commenced duty with the Homicide Unit of the Major Crime Squad South. My work partner at this time was Detective Sergeant Steve McCann. Prior to my transfer to the Homicide Unit, Detective McCann had been involved with the investigation of two murders, one being Richard Norman Johnson at Alexandria on 24 January, 1990 and the other being Kritchikorn Rattanajurathaporn at McKenzies Point, Bondi on 20 July, 1990. Both these investigations resulting in people being arrested. My involvement with those investigations related to brief preparation.
- 7. During these investigations and in a subsequent inquiry into the murder of Ludwig Johann Gertsch at Paddington, another homosexual victim, we expanded the inquiry and identified other incidents involving other homosexual males committed by groups of youths in Bondi and Alexandria. Both the parks at Alexandria and Bondi were identified at that time as being a meeting place for male homosexuals who engaged in sexual liaisons. These locations were referred to within the gay community as being 'beats'.
- 8. As it transpired we established there were no links between the murder of Gertsch and the incidents involving the groups of youths targeting homosexual males at Bondi and Alexandria, although the murder of Gertsch had been a catalyst in expanding the inquiry into the other incidents.

9. These inquiries indicated possible links between these murders and a number of offences committed against homosexual males who had associations with 'gay beats':-

17. On 3 July, 1991 Detective Sergeant McCann prepared an affidavit for the use of Listening Devices relative to the investigation of the deaths of a number of male persons who were believed to be homosexuals. These offences were believed to have been committed by groups of juveniles. The purpose of this application was to record conversations between NP21 and NP16 at the Minda Detention Centre. I assisted in the preparation of this Affidavit and was aware of the accuracy of its contents at the time.

I PRODUCE THAT AFFIDAVIT (ANNEXURE 13)

18. The Listening Device was used pursuant to the Warrant on three occasions:

Between 10am and 12.30pm on 5 July, 1991 Minda Detention Centre. Between 9am and 11.40am on 7 July, 1991 Minda Detection Centre. Between 9am and 12.30pm on 15 July, 1991 Minda Detention Centre. The conversations between NP21 and NP16 included NP16 's involvement in a number of assaults upon homosexuals in the Alexandria and Bondi areas. Insufficient evidence was obtained for the arrest of any person due to insufficient information to establish the exact time, date and location of offences and information was often heresay.

I PRODUCE THE TRANSCRIPTS OF THOSE CONVERSATIONS. (ANNEXURE 21)

19. On the 10 August, 1991 Detective Sergeant McCann prepared a document entitled, 'Over view of homosexual murders and incidents within the inner city area - inner city gay murders.' I assisted in the preparation of this report and was aware of the accuracy of the information it contained.

20. The investigation was suspended due to absence of admissible evidence to support criminal charges against any individual or group of individuals. The investigation established that during this period members of the homosexual community within the Bondi and Alexandria beat areas had been subjected to serious assault and robbery offences by predatory groups of juveniles. The recorded conversations and intelligence indicated that the group were prolific in their violent offences against homosexuals between December 1988 to July 1990 in these areas although many such incidents remained unreported to police.
