I hope you are keeping well.

Yes. The Parrabell academics still exist. We hope we have not been *conspicuous in our silence* (well.....

lack of emails as more befitting this saying in the modern era).© We have been hard at it (and let me tell you that it has been a harder and more time consuming task than any of us could have imagined).

Willem and I have sent a 12,000 word draft of our report to Dr Danielle Tyson to read (it will be good to have a fresh pair of eyes cast over our collective writing). Yes. It's much longer than envisaged. A necessary evil it turns out to be comprehensive.

No doubt some sort of executive summary can be created for the front.

It is 90% (give or take) finished and now the process of ensuring it is coherent and well-structured begins (we may have to move a few sections around).

Then –as mooted in the timeline – we plan to share the draft with NSW police to seek a unified response from you guys [I am sure I stipulated how this might work best in a previous email]

Given that very little (almost none ☹️) academic writing exists, can you bounce me some initiatives/approaches/achievements (in relation to NSWPF understanding, tracking, responding to BIAS crime) that I might incorporate or showcase?

It strikes me that armed with this data I can fashion something positive to show that NSW police are responding as best they can to hate (Bias) crime.

- E.g. – when did the 'NSWPF Bias Crime Unit' get created (how many people work for it etc)
- Community Outreach programs linked to gay hate
- Crime prevention programs linked to BIAS?

I just don't have the internal cultural knowledge to write this section from scratch.

Even if you can only send me bullet points - that would help.

We are still awaiting the release of 3 cases from Unsolved Homicides that Cameron is processing. A bit frustrating as new “fresh” data will have to be incorporated when Craig sends us the files. Hopefully we will get them soon.
