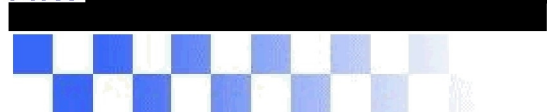

As discussed please start making arrangements to gain access to the 3 matters encompassing Taradale (Mittaini, Russell, Warren) with the UHT. I believe that these matters should be housed at UHT ? given that they are unsolved and previously 'active'. If you meet resistance please let me know as its my understanding that DSupt Willing has now requested that we review these matters.

Before I determine the amount of resources to commit to these reviews and/or timeframes I would like to get an estimate of the volume of material we will be looking at. Either way the material will have to be transported to SH for review (unless its more suitable for us to access UHT at their location).

I think we will also need to examine SF Taradale files - can you check if UHT have them ? if not we need to find where it is archived ? or we may be able to access them via e@glei (as I think Taradale was around 2004/2005 so e@glei should have been utilised ) alternatively we may just be able to look at Taradales files if they extensively cover the original documentation ?

Can you please advise me as to the following

- \* Where the 3 matters are currently located - UHT, archives etc ?
- \* Volume of material for each matter ?
- \* Taradale reinvestigation ? where, volume of material ?

Once I know what we are in for I can decide on resources and advise Mr Crandell of a timeframe.
