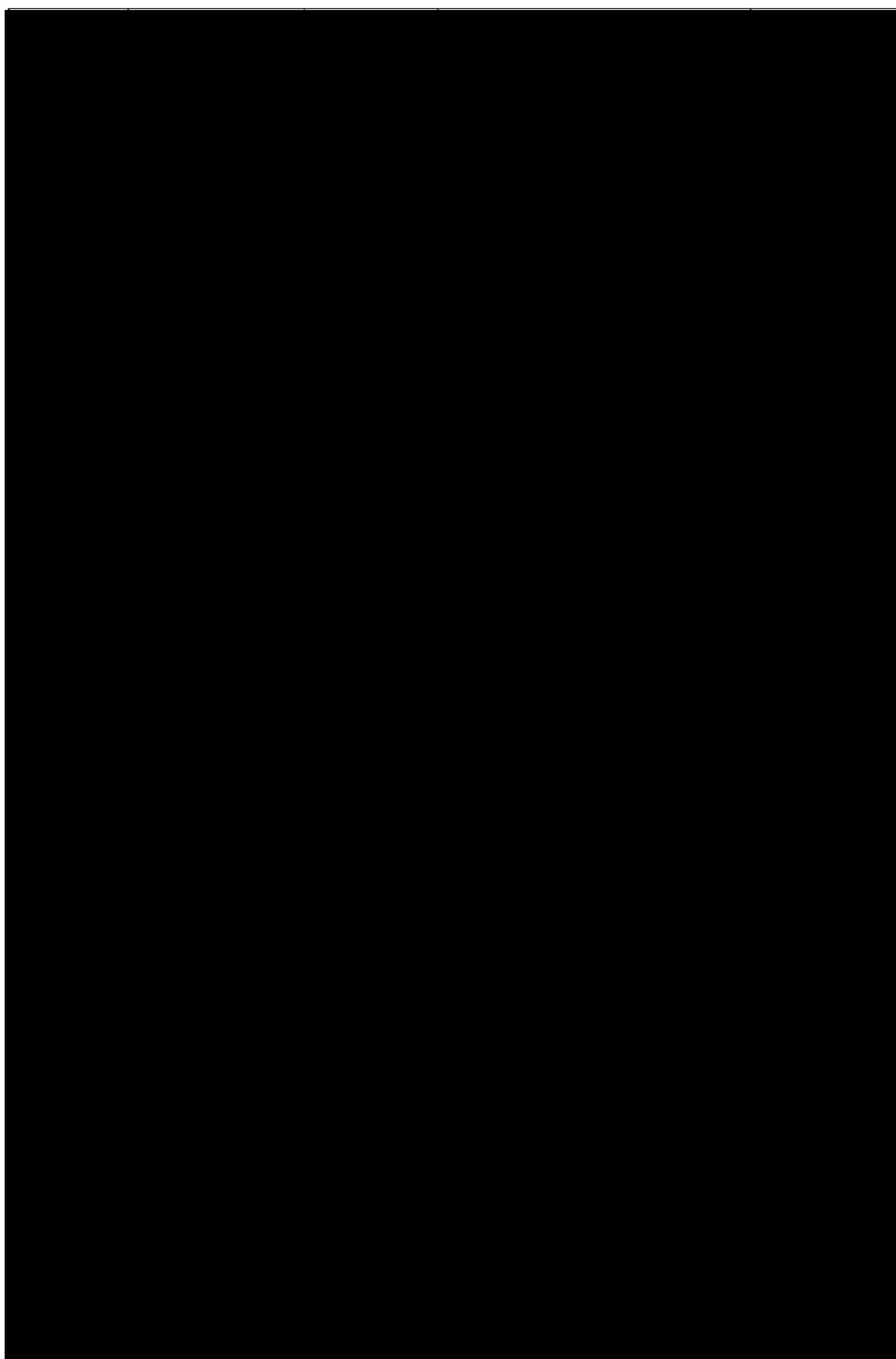

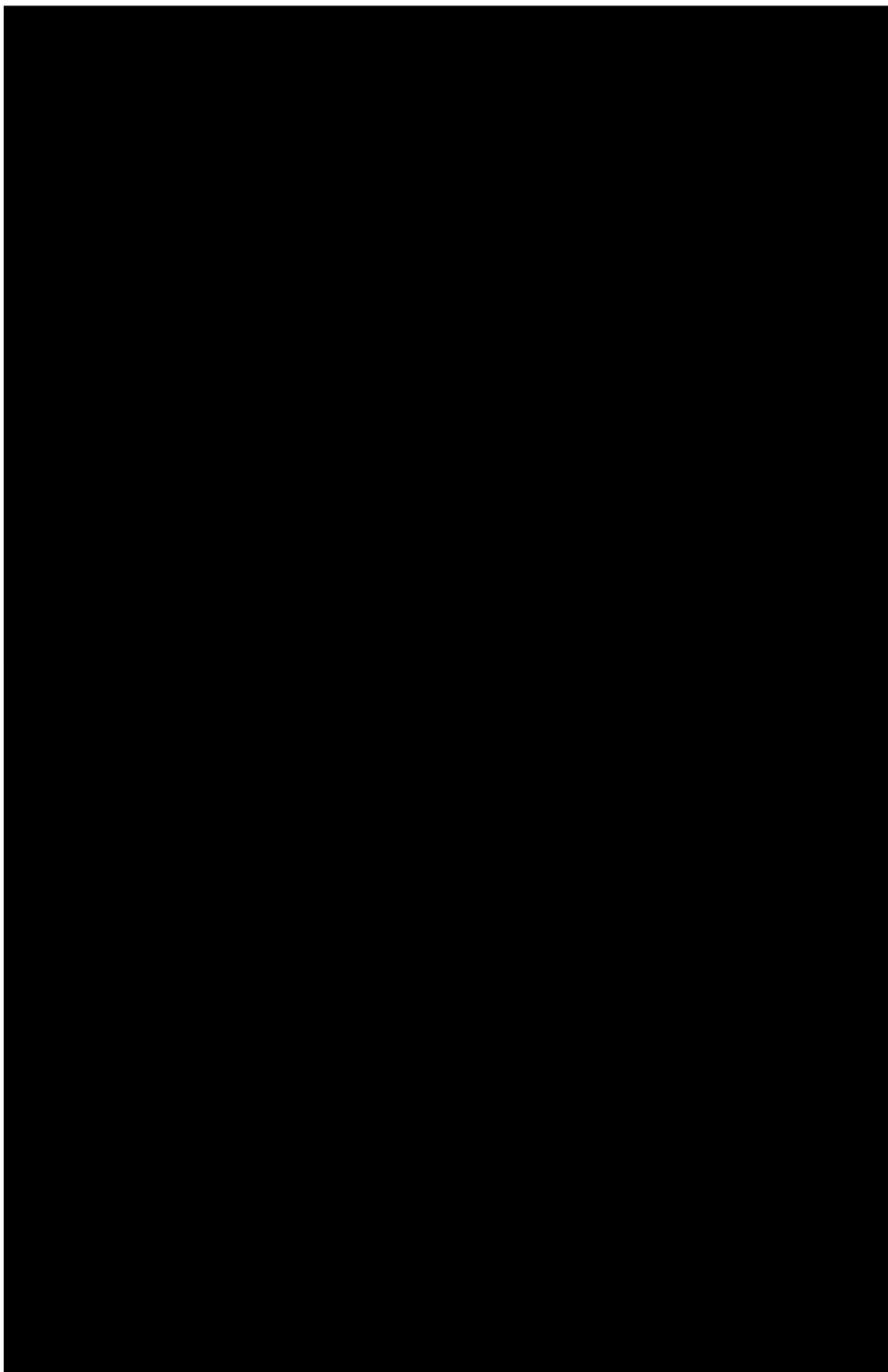

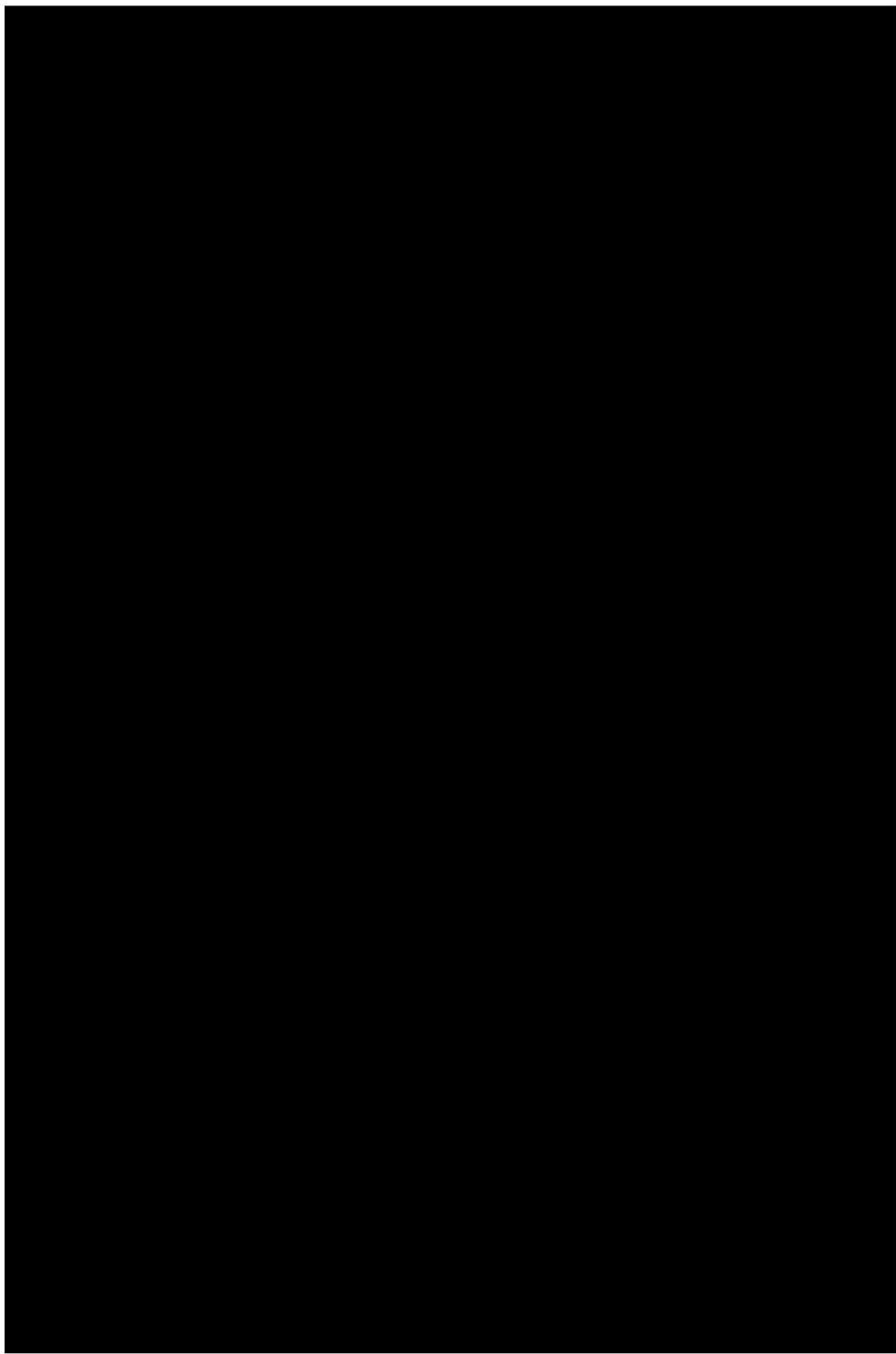

The Johnson family spoke to media afterwards, saying there could be up to 50 perpetrators of gay hate crimes still alive today. In court, John Agius (representing the family) said police had opposed a third inquest.
