# Operational Travel Request – Detective Senior Constables Kilani and Chebl – New Zealand

**Purpose: Seeking decision** 

Topic

Two detectives from Unsolved Homicide Team to travel to New Zealand

Key Analysis Approval is sought for two NSW Police Force officers to travel to New Zealand to gather evidence in respect of three suspicious deaths between 1985 and 1989 – SF Neiwand and SF MacNamir.

### Recommendations

The Minister approve the overseas travel request for:

- Detective Constable Tamer KILANI and
- ii. Detective Constable Michael CHEBL

to undertake operational travel to New Zealand.

The Minister sign the attached advice from the NSWPF (**Tab A**), authorising a total travel cost of \$2618.79 AUD.

#### **Timeframes**

Intended departure date is 2 June.

Key reasons

# Witness statements are needed in connection with possible 'gay hate' murders from the 1980's.

Two witnesses in New Zealand have agreed to give formal statements to assist in the investigation of three cases of suspected or possible homicide (one is a missing person) from the late 1980's. The Unsolved Homicide Team is investigating the offences, which may have been motivated by hatred of gay men.

Police will interview a witness in Victoria who can assist with establishing the last known movements of missing person Ross Bradley Warren on 22 July 1989. Her evidence could assist in investigating inconsistencies in versions of events given by known persons of interest..

### One of the cases is the high profile death of Scott Johnson

Mr Johnson's death was classed as a suicide, but many, including his family, belief he was the victim of a hate crime. A fresh coronial inquiry has been established and is due to recommence on 13 June. Police have been requested to obtain a statement from a witness who claims that a man he was in a relationship with in 2003 had admitted throwing gay males off cliffs in the Bondi area.

### COMMENT:

- 1. The application for operational overseas travel is supported by the applicant's Command.

1 Objectives, itinerary and background

#### Strike Force NEIWAND

The objective of the proposed overseas travel is to interview and obtain an evidentiary statement from witness Amanda Jane EVANS, born EVANS lives in Mount Eden, Auckland, New Zealand. The statement relates to Strike Force NEIWAND is an investigation into the suspicious deaths of three males in Sydney's eastern suburbs between 1985 and 1989. One of these males was Ross Bradley WARREN, who was last seen in the early hours of July 22 1989. WARREN's body has never been located. It is believed he may have been met with foul play and subsequently murdered. Investigators are currently focussing on the last known movements of WARREN and, in doing so, have contacted witnesses who knew WARREN. This contact has enabled investigators to a gain a greater understanding of WARREN's lifestyle and his intended plans on the evening of his disappearance. Persons of interest have been identified and have supplied police with a version of events surrounding WARREN's disappearance. Investigators have identified inconsistencies in these versions, with this requiring further examination. The witness, EVANS has spoken with police by phone and supplied information via email. Her information assists in establishing that inconsistencies identified in the versions supplied by the persons of interest are further explored.

The new evidence to be obtained from EVANS' statement is vital to the investigation. Taking the statement in person will allow investigators a greater opportunity to obtain a more detailed statement.

#### Strike Force MACNAMIR

On 10 December 1988, the body of Scott JOHNSON, born 27 November 1961, was located at the bottom of the cliffs at North Head, Manly. Initial investigations concluded that no foul play existed and attributed his death to suicide. Strike Force MACNAMIR was established by the Homicide Squad in 2013 to re-investigate the death and establish if JOHNSON had in fact met with foul play. The investigation is currently part heard at inquest before the NSW State Coroner with a recommencement date of 13 June 2017. On 17 February 2017, New Zealand , born , sent an email to an National. 194 associate informing her of him being in a previous relationship with a male in 2003 who had allegedly made admissions of throwing homosexual males off cliffs in the Bondi Area. A similar message was posted in 2016 on a Facebook page named Justice for Scott Johnson. This information became known by Strike Force 194 by phone. MACNAMIR, who spoke with informed police that he prepared to meet with investigators in Auckland, New Zealand and supply a formal statement. The Crown Solicitors assisting the State

Coroners have subsequently issued a requestion requesting a statement be obtained from 194
As with EVANS, the information to be supplied by 194 I is relevant to the Strike Force MACNAMIR investigation and will aid in establishing the truth surrounding Scott JOHNSON's death.
Offence of murder, under s.18 of the NSW Crimes Act 1900 carries a maximum penalty of life imprisonment.

On 10/04/2017, Detective FITZGERALD authorised New South Wales to obtain the witness statement in New Zealand. As requested, DSC KILANI sent an email to Detective FITZGERALD on this same date detailing the planned enquires to be conducted in New Zealand.

### 5 Health, safety and insurance

Nil vaccination or disease protection requirements required. The destination has been assessed for security issues via the Department of Foreign Affairs and Trade website. At present there are no security issues of concern for travelling NSW Police.
