Thank you for your letter (**attached**).

Our instructions from **1446**, Detective Sergeant Taylor and Ms Jacqueline Braw have evolved since the correspondence from the Inquiry was sent to each of those persons inviting them to put on a statement.


We note that a statement of **1446** was provided to the Inquiry on 15 September as noted in your letter.

In respect of Detective Sergeant Taylor, we received confirmation of instructions from Sergeant Taylor last week that she intended to put on a statement. That statement is being finalised and we expect to be in a position to provide it to the Inquiry tomorrow.

We do not presently have instructions from Ms Braw to provide a statement to the Inquiry.

We otherwise confirm that we are taking steps to provide the application for non-publication in respect of **1446** evidence by 9.00am on 20 September, as requested.
