#### Special Commission of Inquiry into LGBTIQ hate crimes

I refer to the above Inquiry and to my letter of 22 August 2023.

As you are aware, the second public hearing of the Inquiry ("Public Hearing 2") is examining the practices of the NSW Police Force ("NSWPF") in its approaches to bias crimes and hate crimes, including in Strike Forces Parrabell, Macnamir and Neiwand. Public Hearing 2 is listed for two additional weeks of hearing scheduled to commence on Monday, 18 September 2023 ("the September hearing").
