Thank you for sending me the letter relating to SF Neiwand. I have read the sections of evidence relevant to me. Thank you for the opportunity to file a statement or submission regarding the matter. I will not be making a statement or submission to the Inquiry as I was not part of the leadership group within SF Neiwand or Unsolved Homicide in general so I would not be able to shed any light on the decisions made and the course of action taken. My involvement in SF Neiwand was minimal and from memory it was task driven, this means investigators assigned me a task and I completed that task. I may have been involved in discussion about the tasks but not about the direction of the investigation. I cannot remember how many tasks I was given and completed (and I no longer have access to the investigation on e@gle.i to check), but from memory it wasn't many. I can no longer remember the detail of the tasks.
