Thank you for your email. I have reviewed the sections in the documents you refer to in your correspondence and there is nothing further to add. The systematic review conducted did not yield the data/information needed in order to develop an assessment tool for operational use. The research was extended but moved onto a Delphi study that was conducted with sworn New South Wales (NSW) Police officers between October 2020 and October 2021. I believe this research better served NSW Police in reflecting on their current policies and practices concerning the policing of hate crime.
