#### In this Summons:

#### "documents" means:

#### As to Strike Force Parrabell:

- 1. All documents evidencing or referring to the reasons for the establishment of:
  - a. Operation Parrabell in or about 2013 (including the precise date when that occurred); and
  - b. Strike Force Parrabell in or about 2015 (including the precise date when that occurred).
- 2. All Co-ordinating Instructions for:
  - a. Operation Parrabell; and
  - b. Strike Force Parrabell.
- 3. All Terms of Reference for:
  - a. Operation Parrabell; and
  - b. Strike Force Parrabell.
- 4. All Standard Operating Procedures for:
  - a. Operation Parrabell; and
  - b. Strike Force Parrabell.
- 5. Any other documents evidencing or referring to the methodology, protocols and/or arrangements pursuant to which the Strike Force Parrabell team was to carry out its work.
- 6. All documents evidencing or referring to the reasons why "Operation" Parrabell became "Strike Force" Parrabell in or about 2015.
- 7. All documents evidencing or referring to the criteria by which, and the persons by whom
  - a. the members of the Operation Parrabell team; and
  - b. the members of the Strike Force Parrabell team were chosen.
- 8. All reports made by:
  - a. Operation Parrabell; and
  - b. Strike Force Parrabell.

- 9. As to the "Bias Crimes Indicator Form" tool utilised by Strike Force Parrabell:
  - All documents evidencing the history of the selection and use of that tool by NSW Police Force prior to the establishment of Strike Force Parrabell in 2015;
    and
  - b. All documents evidencing or referring to the reasons for its selection as the tool which Strike Force Parrabell was to use.
- 10. All documents evidencing or referring to any enquiries made by NSW Police Force, either
  - a. when Operation Parrabell began in about 2013; or
  - b. when Strike Force Parrabell began in about 2015,

as to whether the list of 88 deaths set out in the Final Report of Strike Force Parrabell represented all, or only some, of the deaths in the relevant period where there may have been a "gay hate" or anti-LGBTIQ "hate crime" factor.

#### As to the academic review of the work of Strike Force Parrabell:

- 11. All documents, including Supply Agreements, Requests for Tenders or Quotations, proposals submitted, and correspondence, evidencing or referring to any or all of:
  - a. the scope and nature of the work which was to be undertaken in connection with the academic review;
  - b. the estimated and actual cost of such work and services;
  - c. the persons or groups who submitted proposals;
  - d. the criteria for selection of the successful proposal;
  - e. the persons who made that selection; and
  - f. the reasons for the selection of personnel from Flinders University to undertake the work.
- 12. All correspondence between the NSW Police Force and:
  - a. Flinders University; and/or
  - b. any of the Flinders University personnel who participated in the academic review of the work of Strike Force Parrabell,
  - c. evidencing or referring to any or all of
    - (i) the terms of engagement of Flinders University and/or any such personnel;
    - (ii) the amount of fees paid or to be paid to Flinders University and/or to any such personnel in respect of that review; and
    - (iii) the methodology, protocols and arrangements pursuant to which the Strike Force Parrabell team and the Flinders University team, whether separately or collaboratively, were to carry out their respective tasks.

#### As to Strike Force Macnamir:

- 13. All documents evidencing or referring to the reasons for the establishment of Strike Force Macnamir in or about February 2013 (including the precise date when that occurred).
- 14. All Co-ordinating Instruction, Terms of Reference and Standard Operating Procedures for Strike Force Macnamir.

  - a. the identity of the members of the Strike Force Macnamir team; and
  - b. the criteria by which, and the persons by whom, the members of the Strike Force Macnamir team were chosen.
- 16. All reports made by Strike Force Macnamir.
- 17. All documents evidencing the dates, and extent, of dissemination of such reports.

#### As to Strike Force Neiwand:
