On the morning of the 211191 Police attended the following named drycleaners and made inquiries as to bloodstained clothing that may have been presented at those establishments for cleaning;

1. Mosman Laundrette, Military Road, Mosman spoke to John MOONEY.
2. Blue and White Drycleaners, Military Road, Neutral Bay spoke to Wendy BOND.
3. Cremorne Drycleaners, Military Road, Cremorne spoke to Armen ASSATAORIAN.
4. Mosman Coin Laundry, Military Road, Mosman spoke to Patrick SOBLNIKOFF
5. Spit Junction Drycleaners, Spit Junction spoke to Deni KOSWARI.
6. Avante Garde Dry Cleaners, 781 Military Road, Mosman spoke to Freda TSOUMBANELIS.
7. Westley Dry Cleaners, 157 Wycombe Road, Neutral Bay spoke to John MCCREA.
8. Spit Road Dry Cleaning, Spit Road, Mosman spoke to Hong GU.
9. The Mosman Washman, 2/148 Spit Road, Mosman spoke to Phoebe LI.
10. Rosemont Dry Cleaning, Cnr Spit Road and Ourimbah Road, Mosman spoke to Sherridan GREGORY and Vicki MACMILLAN.

Each of these dry cleaners excluding Rosemont Dry Cleaners stated that they had not received any bloodstained clothing and would contact Mosman Police Station should any such soiled clothing be presented for cleaning.

The cleaner at the Rosemont Dry Cleaners, Sherridan GREGORY stated that she had cleaning a pair of mens trousers on the

201191 which had bloodstains to the pocket and cuff area. When further questioned she stated that she could not remember any detail of the description of the soiled trousers due to the volume of trade. Nor could Police be provided with information as to the owner of the trousers. This dry cleaners is located opposite the Garrison Retirement Village where the deceased's friend, Arthur ASHWORTH resides. A check of the dockets for the 20.11.91 was checked, however, no ASHWORTH was located. GREGORY did state that it was not unusual to receive bloodstained clothing from residents of the retirement village.
