MURDER OF WILLIAM JAMES DUTFIELD AT 11/102 SPIT ROAD, MOSMAN

About 11am this date, Arthur ASHWORTH of [REDACTED] Spit Road, Mosman went to [REDACTED] Spit Road, Mosman to check on the welfare of the deceased William James DUTFIELD born 21.5.50. who resided at that address.

ASHWORTH then entered the unit by means of his own key and upon entering the lounge room found the deceased lying face down on a lounge chair with severe injuries to the back of his head. ASHWORTH then contacted Police via 000.

Inquiries have so far revealed that ASHWORTH born [REDACTED] was also the last person to see the deceased alive about 8pm the previous night, the 19.11.91.

The unit revealed no indication of a struggle and two glasses possibly containing wine were located on a tape dispenser with bloodstains was located in the kitchen sink.

The deceased was wearing a blue tee shirt, blue shorts, grey socks and beige shoes. His wallet was on the lounge room floor near the body. There was no money located in the wallet or elsewhere in the unit.

A Post Mortem was carried out at the City Morgue about 6pm this date and the cause of death was verified as multiple skull fractures (in excess of twelve) delivered by a blunt instrument.

A canvass of the unit block located several persons who heard loud thumping noises emanating from the deceased's unit between 9.30pm and 10.30pm the previous evening.
