**1. Location of Brief of Evidence.**

The original investigation documents must be located. The current location of these documents may depend upon the date of the murder you are reviewing and who conducted the inquiry. If the investigation is relatively recent, it may still be stored at the Local Area Command, which had carriage of the matter. Inquiries which were conducted by the former Major Crime Squads and investigations that are considerably more historical, will most likely be located at the Corporate Archives Records Repository, Bridge St, Stanmore, Ph: 95198189.

A manual inspection of the investigation records must be conducted as experience has shown that in older cases, exhibits are sometimes stored in the boxes along with the documents.

Many investigations will be voluminous and the transport of the entire investigation to an LAC office may not be viable. Facilities exist at the Archives for the documents to be inspected and an inventory conducted. Depending on the type of investigation management used during the inquiry, the investigation may be reviewed electronically. All former TIMS inquiries located by the Investigative Systems Support Unit have been converted into E@gle.i investigations. Secondary investigations into the same murder may also be recorded on E@gle.i. To obtain 'read only' access to the investigation contact should be made with the SSU on E/N 53909.

## 7. Exhibits

The original Exhibit Book is obviously the best place to begin to track the movement and location of exhibits. Many homicide exhibits however were never entered into Station exhibit books as they were recovered from crime scenes by Crime Scene Officers and entered into Registers at the particular office at which the Officer was attached. From there, many were forwarded to DAL and other experts. Inquiries have revealed that there is still a large store of exhibits held at the CSU Satellite Offices. DAL are in possession of thousands of samples taken from exhibits for the period 1986 –1997. These samples were not analysed and a DNA sample placed on the data-base. From 1997, all DNA profiles obtained from samples were placed on the database.

Attempts should be made to locate all exhibits and determine what examinations have already taken place. The table below should be completed.

### 8. Fingerprints

There was no electronic fingerprint database in existence prior to 1986 when N.A.F.I.S. (National Automated Fingerprint Identification System) was established. All fingerprints were categorised and searched manually. When N.A.F.I.S. was established this enabled the capability of searching fingerprints electronically rather than by manual means. Palm prints for serious crime were back-captured on N.A.F.I.S. Fingerprints retrieved from homicide crime scenes were collected and filed in unsolved homicide files at the Fingerprint Latent Unit – Major Crime. All historical Fingerprint Major Crime Files are held with the Records Unit on Level 1, Tower B of Police Headquarters. (A list of these case files are in possession of the Commander, Latent Print Section, Fingerprint Operations, Criminal Identification Specialist Branch (C.I.S.B.)). Contact can be made with staff at the Major Crime Response Section on 27388 For cases occurring after 1986 results can be viewed through FCSR. In May 2001 N.A.F.I.S. was upgraded (N.A.F.I.S. 2) which allowed the capability of searching palm print impressions. It would appear that there are no archived records dating back to prior to 1971.

## 9. Witnesses

Witnesses are not to be contacted during this process, as the relationship between witnesses and suspects is not always known. The relationship between them may have changed over time and there is the possibility that the suspect may be alerted to a renewed investigation.

Also, it will not be desirable to raise the hopes of relatives, secondary victim's etc; that their matter will be re-investigated when it may be the case that nothing further can be done.

Witness lists must be extensive however inquiries will only need to relate to witnesses who provide significant evidence. Inquiries regarding witnesses should be confined to COPS, Intelligence Reports, RTA, Electoral Roll, Registry of Births Deaths & Marriages etc.

**11. Synopsis:**

<p>Synopsis:</p> <p><b>Profile:</b></p> <p>William James DUTFIELD was born on the 21<sup>st</sup> of May 1950 at Crows Nest Hospital. He had five brothers. He grew up in Dee Why and went to school at Dee Why Primary then Manly Boys High. At 15 He left school to become an apprentice jockey for trainer Jack GREEN. He continued in this field until about 27 old.</p> <p>His personality apparently began to change and he had limited contact with family. They knew of only one friend although he certainly had more. He was depressed and resorted to drinking alcohol. He stayed with a couple of different people over the years. On moving to [REDACTED] Spit Rd, Mosman, he commented he wanted to meet other people and improve his communication skills.</p> <p>Overall he was a very private person. He kept his homosexuality to himself and did not disclose his 'after dark' activities even to those considered friends.</p> <p>In October 1991 DUTFIELD was assaulted and robber in his home address. The matter was investigated at the time with no person of interest identified. Items were seized as exhibits however no fingerprints were developed at the time.</p> <p><b>Details surrounding finding of the body:</b></p> <p>11:03am on Wednesday 20 November 1991 the body of William James DUTFIELD was found lying face down on a lounge chair of his home unit at [REDACTED] Spit Road, Mosman.</p>

DUTFIELD was apparently dead suffering from massive wounds to the back of his head. At the post-mortem it appeared as though the victim received twelve blows to the head. A defensive wound appeared on his left palm along with bruising to the left elbow and upper arm.

His head was face down on a lounge chair with legs dangling on the floor. He was dressed in a blue short sleeved shirt, blue shorts, white short socks and shoes.

Body discovered by a long time friend and the unit owner Arthur William ASHWORTH, 76 old, of The Garrison Retirement Village, Spit Road, Mosman. He immediately contacted Police, who arrived shortly after.

**Examination of the scene by police, points of note:**

- no foreign fingerprints identified within the unit
- heavy metal sticky-tape dispenser located in kitchen sink, bloodstained and apparently wiped down
- two glasses with liquid (thought to be scotch or similar) on table in lounge along with ashtray containing cigarette butts
- bottle of Scotch almost empty
- room virtually undisturbed with exception of slight rucking up of rugs on ground
- blood stained tissue in waste bin in kitchen (tested and found to be foreign blood)
- It was surmised that the deceased was seated facing his television and the offender has hit him from behind with the metal sticky tape dispenser. DUTFIELD was able to turn in an effort to defend himself before being killed. Defensive wounds are on his arms and hands.

**Last movements:**

It appears that the deceased was last seen alive between 8pm and 9pm on Tuesday 19<sup>th</sup> November 1991 after going out to dinner at the Mosquito Bar Restaurant, Mosman with ASHWORTH. No person was found who could identify DUTFIELD as being alive and anywhere other than at his unit after 9pm on 19th November 1991. ASHWORTH told Police prior to leaving the unit he cleaned up the glasses he and DUTFIELD had used and noticed the bottle of scotch to be about 1/3 full.

It would appear that DUTFIELD and the offender had a drink together prior the murder occurring as when located the bottle of scotch was close to empty and two glasses with liquid were on the table in the lounge where DUTFIELD was found deceased.

Time of death was estimated by the Govt. Medical Officer Dr Joseph DE FLOU as around 10pm to 11pm. This is supported by witnesses [158] and [159]. They resided in units within the block and both heard a thud from the unit of DUTFIELD around 10pm. [159] unit was under DUTFIELD and she heard an argument preceding the thud.

Three lines of inquiry were looked at by the original investigating team:

- a) that the deceased contacted by telephone a male person to attend the unit (possibly a male prostitute)
- b) that a male person, known to the deceased, attended the unit after ASHWORTH had left
- c) that the deceased left the unit after ASHWORTH had gone home and shortly after returned home with a male person. This theory was considered unlikely due to the time limit involved between ASHWORTH leaving and the noises being heard by neighbours and the approximate time of death ventured by Dr DE FLOU.

ASHWORTH was excluded as a suspect early in the investigation due to age and physical condition.

A canvass was conducted with information forthcoming from persons recorded and

statements taken. As noted above witnesses recall hearing a thud from the deceaseds unit between 9:30pm and 10:30pm on 19/11/91. This time corresponds with the estimated time of death given by Dr DEFLOU.

Despite a number of canvasses and appeals for information very little interest was shown by the media and very little information came from the public.

All the phone numbers from the deceased's phone book followed up and persons excluded.

Places frequented by DUTFIELD attended by Police and canvassed.

A number of people were spoken to as **persons of interest** including:

**NP65** (CNI: [REDACTED]) - a male prostitute. He was provided an alibi by his girlfriend (Linda LAWLESS, dob: [REDACTED]). A little vague as to activities on the night of the murder. Came to attention of investigators as he was spoken to by Police after a dispute with a taxi driver in Avenue Rd, Mosman, on 10/11/91. **NP65** was on way, allegedly, to a client but could not pay the fare. Due to his occupation and places frequented he was considered at the time. However he was not considered a suspect by the officer in charge Det. Sgt. O'TOOLE in his statement made in 1994.

**NP62** (CNI: [REDACTED]) - a witness, **I57** from unit [REDACTED], recalls DUTFIELD receiving visits from a male known only as 'Paul'. Inquiries through the "Bottoms Up" bar led to **NP62** being identified. In his statement, made in 1994, the officer in charge Det. Sgt. O'TOOLE indicates that through the investigation the 'Paul' mentioned by the witness was not identified so it would appear **NP62** was eliminated as the person who was visiting DUTFIELD.

**POI nominated but not spoken to:**

**NP64** (CNI: [REDACTED]) was nominated by Sue THOMPSON (now ex-member) as a person responsible for a number of assaults on members on the gay community. In 1985 he went before the Glebe Coroners Court in relation to a murder but it would appear this did not result in charges being laid and was an incident involving a group of people assaulting two others on the street. It would appear the **NP64** was one of many persons linked to assaults on homosexuals in the mid-1980's to early 1990's. On talking to THOMPSON I established **NP64** M.O. was to go home with the victim, drug them then rob them. He was never reported to have assaulted them nor committed offences on the street.

In his statement, made in 1994, the officer in charge Det. Sgt. O'TOOLE indicates that through the investigation a number of inquiries were made with local residents who were nominated as potential suspects but all these persons were eliminated at the time. A list is included amongst the case file items. The list contains details of twelve people but NO reason as to why they were considered suspects. This was also noticed by SF LINCOLN investigators in 1998 and they were unable to determine why the persons on the list were considered as suspects. I think from reviewing the material the persons were persons of interest as they were considered to have means, motive and opportunity. All were in some way linked to the gay community, whether by prostituting themselves (to support drug habits eg. **NP65**) or known to deliberately target homosexuals and assault them (eg. **NP64**). A list of all the persons of similar nature would be lengthy as evidence given at the inquest was that there were numerous persons committing offences against members of the homosexual community in the period DUTFIELD was murdered.

SF LINCOLN (1998) re-opened the investigation as it was believed this offence may have been linked to the ARKELL murder. The thought within the SF was that the murder of DUTFIELD was the early 'work' of a predatory killer who then progressed onto killing and dismembering victims. A review of the original fingerprint case was conducted in 1998 as part of SF LINCOLN and yielded a result. The fingerprints of **NP63** (CNI: [REDACTED]) were found on cellophane from a cigarette packet left at DUTFIELD's unit by the offender who assaulted and robbed him in October 1991. [REDACTED]

interview. Operation did not take place on [REDACTED] [REDACTED] No other information in relation to the DUTFIELD murder was forthcoming during the time SF LINCOLN was run. ARKELL was found to be an unrelated offence.

**Possibility offender same as from similar offence in Five Dock:**

Informant willing to assist but remain anonymous: This informant was a victim in a violent robbery and most certainly would have been killed had Police not been notified and in attendance. Like DUTFIELD he had liaisons with males often bringing them home from pubs. The offender and victim had drinks and used a weapon of opportunity, a lamp stand, to assault the victim. The offender broke out of the house while Police tried to gain entry at the front. Forensic material and fingerprints were obtained from the crime scene and may be worthy of review and comparison to the DUTFIELD offence. No person identified to date for this offence. E 907729100062 relates. This incident was followed up without success as it was considered very similar to DUTFIELD but for Police intervention.

**Exhibits:**

No foreign prints were found during the initial tests. Partial prints were located on the metal sticky tape dispenser and are being subjected to further tests in 2005.

Foreign blood was located on a tissue within the kitchen waste paper bin.

Evidence given at the inquest was that the entire unit had been wiped down. This was assumed as no prints were found, not even prints of the deceased, within the unit on known regular contact points. The unit was extensively examined for fingerprints. Prints located on the whiskey bottle were the victims.

Advice from DAL (2005) was the foreign blood from the tissue in the waste paper bucket was not from [REDACTED] NP63 nor does it match any persons on the database as it currently stands. The cigarette butts yielded a profile matching the deceased's. Complicating the sampling of the cigarette butts is the low amount of material in them. This is likely to have occurred due to the use of a plastic cigarette filter which hinders the transfer of saliva from the donor to the cigarette butt. DAL also indicated that NO foreign DNA was located on the metal sticky tape dispenser. A report for this is yet to come. DAL ref. FS05/2452.

**12. Recommendation:**

You must submit a recommendation on the potential for any further investigation, including the scope of any subsequent investigation eg; opportunity for DNA link, potential for Undercover Operative to be employed, witnesses to be reinterviewed due to change of circumstances. If you recommend that further investigation should take place, list the most appropriate contact person should be listed.

**Recommendation:**

A re-investigation is warranted and the likelihood of a result exists. A reinvestigation would look at the following lines of inquiry:

**Exhibits:**

- 1- Further examinations on the cigarette butts and tissue paper sample utilizing present day techniques with view to narrowing the number of persons of interest. These are at DAL and Virginia FREEDMAN is in the process of examining them.
- 2- Re-examination of the sticky tape dispenser. Presently at Westmead Laboratories subjected to re-examination by Michael BELL.
- 3- Review of fingerprints and other forensic material from the violent assault on Neville CLIFFORD. This attack very similar in nature to that on DUTFIELD however neighbours contacted Police who attended and no doubt prevented the murder of CLIFFORD. E 907729100062 relates. Det. O'TOOLE indicated in the inquest that no persons had been identified from this assault and fingerprint reviews were regularly conducted.
- 4- Submission of the cloth used to wipe down the sticky tape dispenser for DNA examination. On hand at Mosman long term exhibit storage within box 2 entered as item 1 on D008015.
- 5- Obtain elimination DNA sample from ASHWORTH. He appears to have been most regular visitor to DUTFIELD and may have used the tissue in days prior. He provided elimination prints but not DNA at the time of the initial investigation. The origin of the tissue has yet to be determined.

**Offender from the October assault:**

- 7- SF LINCOLN, as mentioned, believed that **NP63** and/or associate/s likely to be the offender in the murder. This theory was raised following the identification of **NP63** fingerprint from the cellophane wrapping from the cigarette packet left at the scene of the October robbery. A strategy put forward by Det. Sgt. ROBINSON is the charging of **NP63** for the robbery.


- 8- Review of **NP63** and his associates. Comparison with profile done by ILLINGSWORTH. **NP63** and/or associate of **NP63** are best place to start given the link to the earlier robbery on DUTFIELD.

**Media:**

- 9- Media appeal and offer of reward. This relies on possibility offender has divulged involvement in the offence to another person willing to come forward when prompted.



