
<p>Comment:</p> <p>On 8th February 2007 a report from DAL was received. The report was written by Virginia FRIEDMAN and signed on 1/2/2007.</p> <p>The significant information contained within the report is that a full DNA profile was obtained from the stained tissue that was recovered from the waste bin in the kitchen of [REDACTED] Spit Rd, Mosman. The DNA profile is confirmed as NOT being from DUTFIELD and at present has not been identified. It is on the database which is regularly being searched and updated.</p> <p>Obtaining a profile from ASHWORTH should be seen as a priority. His profile is required for elimination purposes or otherwise. Due to his age time may be limited and once he has passed away the opportunity may well be lost.</p> <p>Other nominated persons of interest then need to be eliminated or otherwise by way of obtaining DNA samples covertly/as suspects overtly/or volunteers overtly. Comparisons continue to be made with the database which is subject to regular searches and updates.</p> <p>A copy of the report has been uploaded onto e@gle_i and linked to the original review.
