One fingerprint developed on dispenser identified as ASHWORTH. Depending on info from Bell, dispenser to be resubmitted to DAL for further blood analysis	Open
2.	DSCH and DB	Fingernails from the left and right hands of the deceased Dutfield to be submitted to DAL for trace DNA	Open
3.	DSCH and DB	Blue shirt worn by the deceased Dutfield to be submitted to DAL for trace DNA in particular the left sleeve of the garment.	Open
4.	DSCH and DB	Blue shorts worn by the deceased Dutfield to be submitted to DAL for trace DNA in particular the pockets of the garment. Deceased's wallet poss. removed from rear right pocket of shorts.	Open
5.	DSCH and DB	Underpants worn by the deceased Dutfield to be submitted to DAL for analysis of any semen identified.	Open
6.	DSCH and DB	Piece of brown fabric with fringe from top of backrest of lounge chair on which the deceased Dutfield was slumped to be forwarded to DAL for trace DNA	Open

15.	DSCH and DB	Hungerford to locate two beer cans which had been located in kitchen waste bin, ascertain whether fingerprinted, if not forward to SLS/FSSB, Pemulwuy for fingerprint examination then to DAL for trace DNA	Open
16.	DSCH and DB	Deceased Dutfield's wig located on floor of lounge room to be forwarded to DAL for trace DNA	Open
17.	DSCH and DB	Hungerford to locate blood stained tissue from kitchen waste bin and forward to DAL for trace DNA other than blood stain	Open
