Time Discrepancy	
Time Line Ashworth stated at home at 8.15pm despite being seen still at Mosquito Bar still at 8.40pm by 160 and 169 167 and 168. Then even by his own statement stated after Mosquito Bar went to Dutfield's House for drinks, cleaned up and then walked home. This would put it at about 9.30pm at home. Statement made to police on the 20/11/1991 and did not mention when he left apartment saw a male enter the lift until RS6/2/3 despite knowing how important it is.	RS6/2/3

Clothing Discrepancy and dry cleaning	
Description of clothing worn by ASHWORTH on the night of the Murder wearing blue/grey trousers and grey coloured top	ST18 <b>155</b> elevator and RS5/8/1 and 5/10/1
On 20/11/1991 Ashworth dropped off blue trousers to Lawrence Dry Cleaners in Wynyard, despite there being drycleaners in Mosman just opposite where he lived. No mentioned in statement mention in RS 6/2/3	RS 6/2/3
Lawrence Drycleaners could not say if blood on trousers or not.	
On the 21/11/1991 police attended Ashworth's house and he handed to police the brown suit he	RS 6/2/3

On the 20/11/1991 Ashworth travels to the city to meet a friend 164. Ashworth and 164 travelled to Wynyard. 164. ASHWORTH stated on the way to a school teachers reunion. From Wynyard ASHWORTH has tried to call DUTFIELD and there was no answer. For some reason has abandoned the idea of going to reunion and travelled to check on Dutfield finding him deceased. identified on a cigarette Packet left behind at DUTFIELD's house after he was robbed on the	
16/10/1991 two weeks prior to the murder. Whilst NP63 was probably involved in the Robbery of NP63 he could not have been informed in the Murder as he was in custody from the 02/11/1991 to 24/04/1992.
