The Courts and the Police in the Manly area, have, over the years attempted, on numerous occasions, to guide this defendant away from this type of offence, but, to this stage, no success has been permanently experienced.

Friends of this defendant have in fact died and this fact does not deter him from actions of this kind.

The defendant is a consorter with the local drug element and particularly with a like recidivist named GB . It is evident that once these two keep company both increase their ingestion of prescribed restricted, and, prohibited drugs.

Other than placing this defendant before the Court, Police have exhausted all available means at their disposal by which the defendant, may, in time, have a better future.

Police were of the opinion that the defendant was too well effected to make a statement pertaining to the circumstances surrounding these charges and admissions in conversation between the defendant and /Police are relied upon in this matter.
