# Special Commission of Inquiry into LGBTIQ hate crimes: Request for records

I assist the Commissioner, Justice John Sackar, in the Special Commission of Inquiry into LGBTIQ hate crimes ("the Inquiry").

### The Inquiry

By way of background, on 13 April 2022, the Governor, by Letters Patent, issued a commission to his Honour to inquire into and report on historical LGBTIQ hate crimes. Specifically, the Letters Patent require his Honour to inquire into and report to the Governor and Premier on the following matters by 30 June 2023:

- A. The manner and cause of death in all cases that remain unsolved from the 88 deaths or suspected deaths of men potentially motivated by gay hate bias that were considered by Strike Force Parrabell; and
- B. The manner and cause of death in all unsolved suspected hate crime deaths in New South Wales that occurred between 1970 and 2010 where:
  - i) The victim was a member of the lesbian, gay, bisexual, transgender, intersex and queer (LGBTIQ) community; and
  - ii) The death was the subject of a previous investigation by the NSW Police Force.

- 3. **Andrew Ronald Currie** (DOB: 5 August 1959) died between 12 and 13 December 1988 at Nolans Reserve, Manly. On 17 December 1988, Dr William Harold Brighton performed an autopsy on Mr Currie (Post Mortem No. 88/2103). Dr Brighton recorded the direct cause of death as "poisoning by a combination of pentobarbitone, codeine, methadone and morphine".

The Coroners Court of NSW has provided the Inquiry with the coronial files for each of the above deceased persons, which include autopsy, toxicology and/or forensic biology reports. However, the coronial files unfortunately do not include any autopsy photographs or similar material taken at the time of the autopsies. Nor can we be certain whether the coronial files contain all relevant reports that may have been prepared in relation to these matters.

In light of this information, please find **enclosed**, by way of service, a summons requiring the production of certain documents held by you in relation to these deaths.

The summons is returnable on **2 September 2022** and the documents may be produced electronically. I note that due to the age of the files, they may be in archives. If further time is required to produce the material, please advise Caitlin Healey-Nash, Senior Solicitor, as soon as possible and indicate when you anticipate the files can be provided.
