1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 23.

3. I currently live at the above address with my husband, Craig and sone Kieron. We have lived at this address for about February, 1991. When we moved in I met the person in number ■ Burnett Street, MERRYLANDS I know this person as John. I only really know him to say 'hi' to and I would only see him about once a week.

4. About 9pm on Wednesday the 22nd of July, 1992 I went into our spare bedroom. When I got into the room I heard two guys singing, I recognised John's voice and I could tell they were in his back yard. John was also playing his guitar.

5. I then went into the lounge room and said something to Craig, he then came with me back into the spare room. Craig walked out of the room almost straight away and I followed.

6. We then went to bed about 9.40pm and went to sleep. About

11.30 Kieron woke up I went into his room which is at the front of the house and started to feed him. I heard a bottle smash next door and some guy was yelling out, " Get off me you fucking cunt. Clear off. Get out of here." It sounded like someone was sitting on him. I then heard John say, " Didn't I give you wine and cigars and you cut me to peices." I thought I heard someone say, " The cops will be here soon." This wasn't John and it wasn't the other guy who screamed out get off me. There was other conversation between these people that I didn't hear, this whole thing lasted about 20 minutes.

7. After I had finished in Kieron's room I walked back into the lounge room and I heard our other neighbour, Kevin. He yelled out to a taxi cab driver who was parked on the other side of the road facing towards the freeway. Kevin said, "Ninety" I couldn't hear the rest of what Kevin yelled to the cab driver. I then heard Kevin's back door shut and then saw him walking back through his lounge room and towards the back of the house. The lounge lights were on and I could see straight into the house. The cab driver drove off towards the freeway. I then went to bed.

8. About 1.15am I heard John screaming out, " Help, Help." About 30 seconds later he yelled, " Craig Help." He said this a couple of times. I woke Craig and got out of bed and as I did this I heard some banging and smashing coming from the back of John's place. About this time Kieron woke up again and I went to him Craig went out to the back rooms of the house. I stayed with Kieron occasionally Craig would come back to me and tell me what was happening.

9. I would describe the taxi driver that Kevin was speaking to as male, late 20's, mediteranean appearance, black curly hair short hair, a moustache and he seemed pretty big. The taxi he
