- Samantha would come to church for the services once in a while. She attended the coffee shop on an irregular basis, sometimes 3 times a week or some weeks, not at all. Samantha would talk to the people from the church but she didn't seem to fit in with the other trans sexuals who attend the coffee shop on a regular basis.

- I know that Samantha had a major operation in late 1988, I think that she was in hospital for about 4 weeks. After the operation Samantha returned to the coffee shop. I then noticed that Samantha wasn't in the same frame of mind as she was before the operation. She seemed to be very depressed and didn't want to talk to anyone. She always used to sit in the middle booth of the lounge and stare at the opposite wall. She would drink coffee, smoke, and stare at the wall for up to 3 hours sometimes. This behaviour was a big change to the Samantha that I knew before the operation.
- I knew Samantha for 9 years, during which time, I was only a friend to talk to occasionally. In the last months of her life, she was very depressed, that depressed that I thought that she was dying or something. Samantha never spoke to me about suicide, or any of her problems. Samantha was just a loner.
