3. I am a Consultant Psychiatrist. I have been practicing since 1971 in this field. I am also a qualified medical practitioner since 1960.

4. I first started treating Samantha RAYE on 20 January 1989. She was refered to me on account of severe depression with suicidal thoughts. In July 1988, she had undergone corrective operative proceedure, male to female.

5. Samantha had multiple medical compilcations since the operation plus a lot of anti social behaviour was directed at her by the neighbours where she lived. Samantha felt totally rejected and that she had been descriminated against by the housing commision. She had been on the piority list for 2 years and had heard nothing. All these factors caused Samantha to lapse into severe depression.

> 6. When she came to therapy with me, she wept openly and said, "I can't stand this much longer, I must get out of there." I was seeing Samantha 3 times a week originally and the last couple of weeks, once a week. The last time I saw her, she seemed resigned to her situation. Her last visit was on 9 March 1989.

7. In the last weeks, Samantha spoke of Suicide to me. She would say, "I'll have to suicide if things don't get better." Samantha refused any medication for her depression.

8. I know that Samantha had a long history of problems with her life. She was borm in New Zealand as a Hermaphrodite, a person with both male and female sex organs.

She told me of a scar on her inner leg which was caused by this alleged attack, but I never saw this scar or medically examined her.

9. I have no doubt that Samantha RAYE would have taken her own life. She spoke of Suicide to me ofter and was in the correct frame of mind to take her own life.
