1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. I am attached to the East Sydney Crime Scene Section of the Forensic Services Group, where my daily duties include the examination of scenes of crime, the collection of physical evidence, the taking and processing of photographs, the preparation of scale plans and the macroscopic and microscopic examination of objects.

3. At 1.05pm on the Monday 11 November 1996 I attended the intersection of Cleveland and Bourke Street, Surry Hills. At that location I spoke to Detective's Richards and Sparks attached to the Surry Hills police station. I then conducted a examination of the south western corner footpath and roadway, outside 'Bar Cleveland'. I also examined a laneway located on the southern side of Cleveland Street, to the rear western side of 'Bar Cleveland'. I then photographed both locations.

5. At 9am on the Wednesday 13 November 1996 I conducted a examination of the deceased clothing received from Detective Sparkes. The green coloured track pants had evidence traces of soil upon the top rear area. The green coloured sloppy-joe had traces of soil upon the rear right side. A grey coloured arm 'sling' also had traces of soil upon it.

6. Within the following days the investigating detectives conveyed a number of articles to the Crime Scene Section office where I carried out an examination upon them. I formed the opinion that none of the articles were consistent with producing the injuries inflicted the upon deceased.

7. From my examination of the deceased at the time of The post mortem, I formed the opinion that the deceased head injuries are consistent with his coming into contact with a large, flat object. The soil that was evident upon the deceased track pants, sloppy-joe and arm 'sling' were all visually similar to the sandy soil that was located within the rear western laneway of the 'Bar Cleveland' Hotel.
