1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is thirty five (35) years.

3. I am the owner of Steven's Pharmacy situated on the corner of Cleveland and Bourke Streets, Surry Hills. I have operated this business for the past eight years.

4. I recall a customer by the name of Carl STOCKTON. He has been a regular patron to the store for the past seven years. Carl STOCKTON lives around the corner from the pharmacy, just a couple of streets away at [REDACTED] Mort Street. He also has postal address of Post Office Box [REDACTED], Surry Hills.

5. I would describe Carl STOCKTON's appearance as tidy, however, he was a depressed character. He also seemed to be a private person as didn't want people to know where he lived. I can say this because I recall him refusing an offer from me to take an ordered item to his house. Carl STOCKTON appeared to have no friends, or enemies. At night he would drive to work at the Chullora rail yards. Carl STOCKTON would frequent the pub across the road, known as Bar Cleveland and drink on his own.

6. According to pharmacy records for this year Carl STOCKTON has been purchasing Anafranil tablets. A container for this drug holds fifty by twenty five milligram tablets. Dr FIELD prescribed the dosage of Anafranil as six tablets to be taken at night. His last purchase of this medication was on the 1st of November, 1996. This medication was for the treatment of depression. Infrequently Carl STOCKTON also purchased Valium. A container for this medication holds fifty by five milligram tablets. Dr FIELD prescribed the dosage of Valium 'as directed'. His last purchase of this medication was on the 8th of October, 1996. This medication was for nerves. Dr FIELD is a psychiatrist and his practise is at 66 Pacific Highway, St Leonards.

7. According to Carl STOCKTON, he injured his arm at work. I think the injury was a broken collar bone or shoulder. Detective ALLISON asked me about a rib injury, however, I am not aware of Carl STOCKTON having any rib injury. He appeared to have recovered quickly from his shoulder injury and told me he was fine. As far I am aware he was not taking pain killers for this injury.

8. On Thursday the 14th of November, 1996 Detective ALLISON showed me a small brown coloured men's wallet. I recall that Carl STOCKTON had an unusual wallet, although I am not sure if this is the wallet or not. When paying for items he did not appear to have a large amount of money in his wallet. Carl STOCKTON always purchased products with cash and recently, with his shoulder injury, he opened an account into which payed an advance of one hundred dollars.




