

# Special Commission of Inquiry into LGBTIQ hate crimes

## SUPPLEMENTARY SUBMISSIONS OF COUNSEL ASSISTING

13 October 2023

### IN THE MATTER OF PETER SHEIL

#### Introduction

- These submissions are filed on behalf of Counsel Assisting the Special Commission of Inquiry into LGBTIQ hate crimes (Inquiry). These submissions supplement the written submissions filed on behalf of Counsel Assisting the Inquiry on 4 April 2023.
- 2. This matter was the subject of a hearing by way of documentary tender on 3 April 2023.

### Subsequent investigative steps

- 3. Subsequent to the hearing of Mr Sheil's case, the Inquiry undertook the following additional investigative steps:
  - a. The Inquiry issued a summons to the South Eastern Sydney Local Health District (SESLHD) for all records held in relation to Mr Sheil, including records held by the Prince of Wales and Prince Henry Hospitals (summons SESLHD2).<sup>1</sup> In response, the SESLHD produced a small Chest Clinic file for Mr Sheil, which related to a brief admission he had in June 1981 for moderately severe asthma.<sup>2</sup> The SESLHD later advised that an additional patient card had been located for a person named "Peter Sheil", but with a different date of birth to Mr Sheil's, which indicated a psychiatric admission. However, the corresponding file for this card was destroyed in 2011.<sup>3</sup>
  - b. The Inquiry made inquiries regarding Patricia Marlene Campbell, who was the supervisor in charge of Mr Sheil's residence at the time of his death. Through the NSW Registry of Births,

Deaths and Marriages, the Inquiry received a copy of Ms Campbell's death certificate, which

indicated that she died in 2021.4

c. The Inquiry wrote to Dr Christopher Rikard-Bell, who was the psychiatric registrar at Prince

of Wales Hospital and provided a statement to the Coroner regarding Mr Sheil's treatment

at the Prince of Wales and Prince Henry Hospitals, to inquire as to whether he had any

records or other information about Mr Sheil.<sup>5</sup> On 4 September 2023, Dr Rikard-Bell spoke

with a solicitor employed by the Inquiry on the telephone. Dr Rikard-Bell informed the

Inquiry that he has no recollection of treating Mr Sheil, and nor does he have any notes

relating to him.6

Comments on the further information obtained

4. The investigative steps outlined at [3] above were undertaken by the Inquiry in order to seek a better

understanding as to Mr Sheil's mental health in the period prior to his death and as to his previous

admissions at the Prince of Wales Hospital and the Prince Henry Hospital. Unfortunately, no records

relating to Mr Sheil's mental health-related admissions were able to be produced. Further, in light of

Ms Campbell's death, the Inquiry was unable to determine whether she had any relevant information

about Mr Sheil additional to that contained in her police statement.

5. Accordingly, Counsel Assisting consider that the information obtained through these investigative

steps above does not require any change to their submissions dated 4 April 2023 as to the manner

and cause of Mr Sheil's death.
