While he was doing this he was very abusive and he said to me something about my car, I think he was going to steal it and I told him it was my parents car and that I had to have it home and my parents would be worried. He said to me, "I'll kill you like I did the other poofter in the laneway." At this point in time I was crying, upset and very scared and when he said this to me I though of a friend of mine who died in a laneway in Wollongong about 6 to 12 months earlier. I made out that I didn't know what he was talking about. He then put the rock in my handsand he said, "I'm gonna smash ya head in with this rock." I was begging him not to kill me at that stage and I said, "Don't kill me. you can do anything you want to me just don't hurt me, don't kill me." He then continued to have anal sex with me and oral sex also. I was doing this out of fear of my life. I was saying to him not to hurt me.

- 8. After he finished, he made me put my clothes back on and walked me over to my parents car put me in the back seat. He got the keys from me when I was getting dresses. He told me to lay down and not to say a word. He then started to drive, as we were driving I looked up and saw that we were driving west in Burelli Street past Woolworths in Wollongong. As we drove he mentioned something like, "There she is," or something similar, I don't know what he was referring too. The next thing the car stopped, he told me not to move for about twenty minutes, I layed there for a while, he was gone and I realised the car was parked at the back of Tattersalls Hotel in Wollongong. I then got into the car and drove down to the Police Station. I spoke to a Police officer and he told me to go straight up to the hospital and then went to the Wollongong Hospital and there I had a medical examination. Later some detectives arrived and I told them what happened but I didn't make a statement at that time as I was very embarrassed about what happened.
- 9. I did not give this man permission to have anal sex with me at any time. At first we did have consented oral sex but when he became aggregative I told him I did not want.

any further sex and the reason I allowed it was in fear of my life.

- 10. I would describe this man as being Australian, about 20 to 25 years of age, a little bit taller than me, solid build, blonde hair medium complexion, looked very young in the face, wearing steel capped boots, blue denim jeans, black t-shirt with a flannelette shirt over the top, he alos had about a two day growth.
- 11. I can remember one thing he said to me when he was sexually assaulting me and that was, "They won't catch me T-11 go back to Cooma."
- 12. Last Sunday the 8 October, 1989 I was at a friends place and he told me something. He then showed me a newspaper article in the Mercury and I saw a man in the picture. I instantly recognised that man as the person being responsible for sexually assaulting me at Nort Beach in 1986.
- 13. Whilst at the Police Station on Saturday the 14 October, 1989, I spoke to Detective DAVIDSON and he showed me a manilla folder containing eight photographs of men. I recognised the man in picture numbered 6 with the number 193 on the bottom as being the man responsible for sexually assaulting me in 1986 and also the man I saw in the nespaper article.
- 14. After looking at the nespaper article, I contacted Detective Sergeant AINSWORTH at the Wollongong detectives and I told him something on the Monday the 9th October, 1989.
