Description:	Simon Blair WARK, aged 28 years was a Technical Officer with the City Art Institute. WARK was located deceased floating in Sydney Harbour near Dobroyd Head. Prior to his death WARK was diagnosed by Psychologist 1181 with depression and was on strong doses of anti depressants prescribed by a GP. 1181 believed WARK'S depression was mainly due to termination of an eight year homosexual relationship. During the post mortem of WARK the deceased was found to have multiple fractures to the spinal column, the left rib cage and the pelvis. These injuries were sustained were consistent with a fall from height. It is believed WARK committed suicide by jumping from the Gap and floated to Dobroyd Head where he was discovered. As such, no persons have been identified as being responsible for the death of WARK.	

### 1. Differences **Prompts** Comment Simon Blair WARK, aged 28 years was Immutable characteristic differences between a Technical Officer with the City Art victim and POI's sexual orientation Institute. At the time of his death WARK resided in a room at The Pyrmont Arms Hotel. WARK was located deceased floating in Sydney Harbour near Dolbroyd Head on the 10 January 1990. Prior to his death WARK was diagnosed by Psychologist I181 with depression and was on strong doses of anti depressants prescribed by a GP. I181 |believed WARK'S depression was mainly due to termination of an eight year homosexual relationship (OD-629). Ex-partner and priest 1182 | I182 | had known WARK for eight years describing him as "a very intelligent young man, who was affable and artistic." I182 also stated WARK suffered from depression which would manifest itself into mood swings (ST-784). Close friend 1179 }, had known WARK for eleven years and was in constant contact with him until his death. "Blair sold and used LSD very heavily over a two year period." He was aware WARK was having an affair with I182 until 6 months before his death. "WARK would tell 1179 about the bashings he received from 1182 however he was heartbroken over the break up as he treated 1182 like the father he never had." (ST-783). Both 1182 and 1179 mentioned in statements to Police that WARK had thoughts of suicide and would converse with them about suicide in the weeks leading to his death. In the days prior to WARK'S death he mentioned to 1182 brushed it off as he was used to Blair making up imaginative stories. On the 8 January 1990, WARK arrived at the family home in a visibly distressed state. He mentioned to his father the Triads were trying to get him. In a statement from WARK'S sister, Rebecca WARK following the death of her brother, she stated to Police, "I describe my relationship with Blair as being close. I would see him regularly, usually at least once a month. We would often talk at

	length about various topics. I know that Blair was homosexual. I do not believe Blair had any problems with this fact" (ST-789). During the post mortem of WARK the deceased was found to have multiple fractures to the spinal column, the left rib cage and the pelvis. The injuries were sustained were consistent with a fall from height (ST-788). On the 11 January 1990 property which belonged to the deceased was located at the cliff tops at the Gap (OD-628). It is believed WARK committed suicide by jumping from the Gap and floated to Dobroyd Head where he was discovered. As such, no persons have been identified as being responsible for the death of WARK.

However 1182 brushed it off as he was used to WARK making up imaginative stories stating, "I was used to Blair making up imaginative stories, which he did on occasion. In a statement from WARK'S sister, Rebecca WARK following the death of her brother, she stated to Police, "I describe my relationship with Blair as being close. Bias related comments, written statements or gestures were made by the POI	There were no suspects identified during the course of this investigation as having been responsible for the death of WARK. During post mortem, WARK was found to have multiple fractures to the spinal column and the left side of the rib cage. A further fracture to the pelvis was also present. Bruising around the neck area of the deceased, which had been detected during an earlier aborted post mortem, was found to have been the result of a spinal fracture at the base of the skull. The liver and a number of internal organs were also found to have sustained damage (ST-788). In the Coroners findings he stated "having perused the completed file I am of the opinion there are no suspicious circumstances in relation to the death of Simon and I believe this is a matter that can properly be dispensed with" (OD-632). As such it is not believed any bias related comments, written statement or gestures were made by any persons at any time during the death of WARK.
Comments and gestures can occur before, during and after the incident	There were no suspects identified, interviewed or arrested in relation to the death of WARK, as such there are no comments or gestures attributed to any persons of interest. The death of WARK was not seen as suspicious and the inquest was dispensed with on the 25 June 1990 by the Coroner. Comments and behaviour made by WARK in the days leading up to his death show WARK was in a state of depression.

There were no suspects identified during the course of the investigation as having been responsible for the death of WARK. As such it is not believed any bias related comments, written statement or gestures were made by any persons at any time during the death of WARK. The death of WARK was not seen as suspicious and the inquest was dispensed with on the 25 June 1990 by the Coroner. Comments and behaviour made by WARK in the days leading up to his death show WARK was in a state of depression. WARK often spoke with witnesses about his thoughts on suicide.

Behind it I noticed a pair of metal rimmed glasses, some receipts and a small tube of ointment. I also saw some money tucked into the shirt, all the property was wet" (ST-787). There is no other information available in respect to crime scene analysis of photographs.

The death of WARK was ruled as non suspicious and not a homicide. The Gap is not known to have had previous bias crimes occur at the location. There is no record of any previous bias crimes on the COPS system however there is a lack of converted data prior to 1992. The Gap is a well known area for people to commit suicide. A number of internet 'gay cruising' sites mention the area of south head and popular Lady Jane Beach as beat locations which are both in close proximity to the Gap. Days before his death, WARK made statements to 1182; Ian WARK, Rebecca WARK and Enid WARK, "the Triads were after him." These comments appear to be unsubstantiated with no evidence available suggesting this was actually the case. WARK'S friends and family did not seem to take the comments seriously with 1182; stating, "I was used to Blair making up imaginative stories, which he did on occasion. These stories were often constructed in such a way as to make Blair the centre of the stage, whereby people were often imagined by him to be talking about him."

### 6. Victim/Witness Perception **Prompts** Comment There were no direct witnesses to the Witnesses (actual) perceive that the incident was death of WARK. WARK'S sister motivated by bias (Rebecca) and mother (Edin) wrote a letter to the coroner in relation to their views on the death of WARK. "Having seen and spoken to Blair only hours before his death neither of us believes that he committed suicide. Blair was so frightened for his life on Monday, January 08, 1990 (and possibly even earlier than that date). Why would he then take his life the following day?" (OD-630). In the opinion of clinical psychologist I181 "Mr WARK suicided himself as a result of depression and loneliness" (OD-629). Both I182 and I179 both mentioned in statements to Police WARK had thoughts of suicide and would converse with them about suicide within weeks of his death. There is no evidence suggesting the people closest to WARK perceived his death to have

been motivated by bias.

All witnesses apart from his family are clearly of the belief that WARK was more than capable of taking his own life and that he was extremely mentally fragile, on antidepressant medication and unstable immediately prior to his death. Although WARK mentioned to his family and friends the Triads were after him, there is no evidence to support that this was the case.

On the 6 January 1990 close friend of WARK,  1179 was with WARK and noticed WARK to be depressed. "Our conversation at this time turned to the subject of suicide. There is no indication from any of the evidence available that any other person was involved in the death of WARK. The death of WARK was not seen as suspicious and was dispensed with at the Coroners Court on the 25 June 1990. Although WARK never mentioned to any person he wanted to commit suicide if was more often than not a topic of conversation with he would often bring it up in conversation. Of relevance is the mental state of WARK leading up to his death. His constant chatter on suicide with his friends, his break up with 1182, his use of antidepressant drugs and he was seeing a clinical psychologist to help him with his depression show WARK was not of a stable mind at the time of his death. WARK was employed as a Technical Staff Officer in the print making department of the City Arts Institute. Close friend 1179, before becoming aware of WARK'S death wrote him a letter care of Pyrmont hotel. 1179 stated, "In this letter I do make reference to suicide and also say that I cannot picture Blair jumping 'rite' now. The reason I wrote this was a a reference to our last conversation and was connected to Blairs' constant obsession with the subject of suicide." The letter also refers to the drug 'LSD'. When at the art institute with Blair, Blair sold and used LSD very heavily over a two year period. The death of WARK was unexpected and was not violent in nature. The cause of death was from multiple fractures to the spinal column, the ribs and pelvis all consistent with a fall from height. Other significant conditions contributing to the death was depression. The Deputy State Coroner D. W. HAND found no suspicious circumstances in the death of WARK and dispensed of an inquest.

and artistic." 182 also stated WARK suffered from depression which would manifest itself into mood swings. In 182 S statement to Police he described WARK'S relationship with him as "being homophiliac. This being a strong attraction by a person of the same sex. This differs from Homosexuality in that a homophiliac is only attracted to a specific person of the opposite sex. This manifested itself in our relationship by Blair always being around me and behaving like a surrogate son. Blair was also very possessive of me and resented the church for working me to hard. Blair was aware of these feelings and because of this he was trying to work through these feelings by going to a psychiatrist and a psychologist, at my suggestion."

Close friend 1179 , had known WARK for eleven years and was in constant contact with him until his death. "Blair sold and used LSD very heavily over a two year period." He was aware WARK was having an affair with 1182 until 6 months before his death. "WARK would tell 1179 about the bashings he received from 1182 however he was heartbroken over the break up as he treated 1182 like the father he never had." Both 1182 and 1179 mentioned in their statements to Police WARK had thoughts of suicide and would converse with them about suicide. This occurred over an extensive period and within weeks of his death.

In the days prior to WARK'S death he mentioned to 1182 "the Triads were after me." 1182 brushed it off as he was used to WARK making up imaginative stories. On 8 January WARK arrived at the family home in a visibly distressed state. He mentioned to his father the Triads were trying to get him.

During the post mortem of WARK the deceased was found to have multiple fractures to the spinal column, the left rib cage and the pelvis. The injuries sustained were consistent with a fall from height.

On the 11 October 1990 property which belonged to the deceased was located at the cliff tops at the Gap. It is believed WARK committed suicide by jumping from the Gap and floated to Dobroyd Head where he was discovered. There were no suspects or offenders involved in the death of WARK. The Deputy State Coroner D. W. HAND found no suspicious circumstances in the death of WARK and dispensed of an inquest.
