**Between 1.40pm and 1.50pm the suspect entered the shop of the deceased and for reasons unknown at the time, he stabbed the victim in the left shoulder penetrating the chest cavity and lacerating the left lung. A second stab wound was thrust between the 8th and 9th rib on the right side piercing the liver. As the deceased staggered out of his shop he fell through the plate glass display counter, severely cutting his left arm.**
