	<p style="text-align: right;">TREBLEY/ALLCORN</p> <p>This date attended premises at [redacted], phone [redacted] and interviewed Mr. 138 [redacted] of that address.</p> <p>138 is employed at the Parramatta Psychiatric Centre as a male nurse and lives at the above address with 143, the Head Tutor for the Psychiatric Centre. From talking to 138 it is obvious that both he and 143 are homosexuals.</p> <p>138 stated that he has known the deceased for four years, having purchased numerous items from his store over the last four years, mainly crockery and statues but also some small furniture items.</p> <p>He said that Bedser would talk about his personal life, talking freely to 138 about his boyfriends and business. 138 said that it was not uncommon for Bedser to ask 138 to mind the shop when he walked in, so that Bedser could go to the bank or to do other shopping. 138 also said that he had been in the shop on occasions when there was a blonde woman working there, mainly Thursday nights. There had also been a male named [redacted] who 138 feels was weird, 17 old, very big build and he lived in [redacted]. He worked for Bedser for about a week two years ago.</p> <p>138 said that Bedser told him that he was working the public toilets and when he picked up a male friend he would take them back to his shop for further discussions in the left. 138 had told him that this was a dangerous business as he was leaving himself open for blackmail, but Bedser said that he was alright. 138 said that Bedser had told him that some jewellery had been missing from the shop, but 138 does not know if it was stolen, or Bedser had given it away, or if Bedser was being blackmailed. Bedser told 138 about NP58, a Greek, and 137 and Australian, both in their teens, one he had given a ring to, 138 thought that teenage boys were trouble and had told Bedser but that is what Bedser liked.</p> <p>The boy 137's Father was an alcoholic, and the Father had threatened cont.</p>

	<p><b>138</b> INTERVIEWED CONTINUED.</p> <p>Bedser over the son sometime in 1979. The boy <b>137</b> had been involved with Bedser during the middle of 1979.</p> <p>The last time <b>138</b> saw Bedser, he was told that <b>NP58</b> wouldn't sleep with him so he had given him up, and he was planning to go to Hawaii for a holiday. He also told <b>138</b> that his Mother was an invalid and that he cared for her at home.</p> <p>Bedser had requested <b>138</b> to sleep with him, but had offered <b>138</b> goods to do so, and <b>138</b> had turned him down as he feels that there should be some sort of caring between persons to do that, and not for payment.</p> <p><b>143</b> <b>138</b> stated that both he and <b>143</b> had attended the funeral of the deceased, prior to going to work.</p> <p><b>138</b> was of the opinion that Bedser didn't like long involvements with his boyfriends, just for short periods.</p> <p>He said that Bedser would put the prices up high if he thought he could get away with it, and also cheat people when buying things when he was aware that they didn't know the true value of the goods.</p> <p><b>138</b> said that there was also another man that worked for Bedser for a short time in 1979 that he describes as a short slim European with short hair and a beard, but he could not describe him any further.</p> <p>Bedser <del>xxxx</del> told him that he had also slept with the man from the Drycleaners in Darcy Street and also with a man from the hairdressers in the arcade.</p> <p><b>138</b> was asked if he had heard anything of Bedser being involved with a female, and <b>138</b> said that it would be extremely unlikely that he would ever have anything to do with females as he had a strong dislike for them, and would make nasty remarks about them when they entered the shop if <b>138</b> was there also, and <b>138</b> feels that if he ever mentioned a 16 year old, it would be a boy and not a girl.</p>

18/12/80	<p><b>138</b> INTERVIEW CONTINUED.</p> <p><b>138</b> said that Bedser had told <b>NP58</b> that he had slept with <b>138</b>, and <b>NP58</b> asked <b>138</b> if this was true, so <b>138</b> feels that Bedser would lie to people if the mood suited him.</p> <p><b>138</b> said that he never went out socially with Bedser, only having dealings with him at his place of employment, and he could not assist with any other friends of Bedser's.
