- 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. - 2. My age is 34 /1963
- 3. I am currently employed as an Analyst Programmer at the Westpac Bank in 140 Phillip Street, Sydney and been working there since December 1994.
- 4. When I joined the Westpac Bank in December 1994 I met David ROSE. At this time David and I did not work in the same area of the Bank and we mainly communicated over the telephone, occasionually speaking to each other face to face.
- 5. Back in June or July 1997 David's team and my team merged so we were working together on a daily basis, both as Analyst Programmers. Even though we were working from the same floor we were still using different applications and therefore would only speak to each other occasionally.

From the time I was employed at the Westpac Bank I knew

that David was a cross dresser. I was aware of this mainly because of the way David dressed. David used to wear ladies pants either tight or loose and most of the time the colour he chose to wear was pink. As well as dressing in female clothing David used to come to work with cosmetics on his face and wear a lot of bracelets on both hands.

- 7. In the last few months particularly since David and I were working from the same floor I noticed that he was wearing tight women's shirts. He always wore a hat that appeared to be made of straw. The hat had a very wide brim and a pink ribbon was tied around it.
- 8. The computer terminal that we work at generally has a black background with green or white characters, however, I saw that David had changed the settings on his terminal and the background on his computer was pink and the characters were often pink as well. Also at the bottom of David's computer screen the name "SAMANTHA" was typed there. On another occasion I asked David to type his personal details on the computer for an application demo and he typed his name as "Ms Samantha ROSE".
- 9. I know that David lived in a unit at Kensington, however, I am not aware if he lived alone. David had told me that he worked in a radio station but did not receive any payment for this work, it was all voluntary. He told me that recently he hadn't been speaking on the radio, he was now training people.
- 10. Back in July 1997 a female I know as Jenny WOOD was married. Jenny works on the same floor that I and David used to and she is a Senior Consultant within the Westpac Bank.

11. The last time I saw David was on Wednesday the 18th December, 1997. On this day he wasn't feeling well and he went
