9. Whenever Sandra goes out she catches a cab. She never talks about where she is going with me.

10. Sandra goes out most days. She leaves in the morning by cab and usually doesn't come back until late, after 10.00pm some time.

11. On Friday the 19/12/97 I was at home all day but I think Sandra went out.

12. On Saturday the 20/12/97 I went out about 6.00am to go to Newtown for a job interview. Sandra was home when I left, she was asleep on the lounge. I got home about 6.30 - 7.00pm. I don't think Sandra was home when I got home.
