I said, "What you done?"
She said, "I must've killed this guy, didn't you see it on telly. The cross dresser. I couldn't have done it. He was my best friend."
I said, "What are you talking about? If you didn't do it you shouldn't say you did. You could be locked up."
4. She said a couple of times, "I might have killed him in my sleep." Then she would say, "No, it couldn't have been me. I must have been drinking."
