This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

My age is 34 ( 63) 2.

I am currently employed as a masseuse at the Bare Bunnies, 3. which is located at 43 Queen Street, St Marys. I have been employed here since December, 1997. My shifts start mainly at 6.00pm and during Monday to Wednesday I finish about 2.00am, and Wednesday to Sunday I finish around 5.00am or 6.00am. I work at the Bare Bunnies with Marsia who is the receptionist, Joanne and Cloe who are also masseuses.

On the 25th December, 1997 I started work at the Bare 4. Bunnies at about 6.30pm, when I walked in I saw a female person that I had never met before. This female person walked towards and said "Hi my name is Veronica."

I said "Hello."

As far as I am aware Veronica had previously worked at the Final Touch which is a brothel about 500m away. I did not have any more conversation with Veronica for the rest of the night because I had a number of customers through out the shift.

> At about 12.00am I saw Veronica walk out the front door 5. carrying her bag, and I did not see her come back for the rest fo the night. About 2.00am the phone rang and the receptionist was in the toilet so I picked up the phone and I heard a male voice ask for Veronica. I said "She left two hours ago" and the male said "ok" and hung up the phone. I continued my shift and finished at 5.30am.

On New years eve 1997 I started work at 6.30pm, as I approached the front door of Bare Bunnies the front door opened and I saw Veronica who I had last seen on Christmas eve. Veronica said "High"

I said "Hello"

I noticed that she a black eye, I cant remember which eye it was.

I walked into work and got charged and waited for a customer.

Around 9.30pm or 10.00pm I was in the foyer sitting on the 7. couch watching T.V. and Veronica was lying on the lounge. Veronica seemed very tired, and sleepy, I said "What's wrong?" Veronica said "I've had two or three hours sleep." Veronica then said "I must have killed this man. I was to drunk, I was half asleep to know what was going on. It can't be me I was with some one." I said "which man?" She said "This cross dresser on T.V., haven't you seen it?" I said "I've seen it on T.V." She said "It can't be me. He was my best friend, It could not be me, I must be dreaming." I said "If you haven't why are you talking like this you are going to get your self into trouble?" She said "Well I'm already in trouble four Detectives came to my house looking for clues and keys and I'm under Investigation. I

Veronica laid back down on the couch and then a short time 8. later Veronica got up and said "I have to call my alibi." Veronica got up off the lounge and went and made a phone call on the public phone which is on the receptionist desk. Veronica was not able to get in contact with the person that she had been calling and over the next half an hour Veronica made about four or five phone calls with out speaking to anybody. One of the other girls Marisa said to Veronica "Who are you trying to call?"

I heard Veronica say "I'm trying to get to my alibi, but I can't get through."

Veronica said "I'll try and ring home to see if any Detectives have been checking on me." Veronica then made another phone call and I heard Veronica say "Have any Detectives been?" Veronica talked on the phone for a couple of minutes and then hung up.

Veronica said "The detectives have been hanging around, and 9. I am sick of it because every draw and cupboard as been turned up side down looking for keys or any clues." I walked out of the foyer then because I did not want any thing else to do with her. I had a conversation with Marisa and as a result of what she told me I had a look at Veronicas arms and thighs and saw that Veronica had a large bruise which went from her knee to her mid thigh, I cant remember which leg it was. Veronica also had a number of smaller bruises on both her upper and lower legs. I also saw that Veronica had bruises over both shoulders and biceps.
