

**ISSUE:**

Dissemination of unsolved homicide case file. Death of David ROSE in 1997 at Kensington. Recommended investigation by Eastern Beaches LAC

**BACKGROUND:**

This is a covering report detailing recommendations for allocation of a case file relating to,

Death of David Samuel ROSE at Kensington - UHT Ref: 1997/13

This unsolved homicide case has been formally reviewed, prioritised and now requires further investigation. It is not intended that this case be fully reinvestigated but that identified avenues of inquiry be pursued in an attempt to resolve any outstanding issues that may or may not lead to identifying or charging specific offenders.

**TAB 1** *Recommendation Report*. Contains,

- a synopsis of the investigation that details the incident,
- recommended lines of inquiry
- recommendations in relation to resources
- recommended time frames, and
- information on secondary victims

**TAB 2** *Case Screening Form*. This form is prepared by the Case Reviewer DSC Natalie BARR and summarises the relevant key aspects of the investigation.

**COMMENT:**

Upon receipt of this case the investigator is requested to,

- Obtain & review the investigation records
- Establish and maintain contact with DSC Natalie BARR at SCC
- Prepare and submit an Investigation Plan
- Undertake the investigations in accordance with the *Guidelines for the Investigation of Major Crime*
- Establish and maintain contact with secondary victims
- Provide secondary victim with support service records

When the investigation is completed the investigator should,

- Establish contact with the NSW State Coroner
- Meet with secondary victims as to any outcomes of the investigation
- Furnish a final report through the chain of command to the Commander Homicide Squad

**RECOMMENDATION:**

That this case be allocated to Eastern Beaches LAC. When determination is finalised, this case file be returned to the Commander Homicide Squad.
