- I am aware that if I sign this statement and 1. any part of this statement is untrue to my knowledge I may be liable to punishment.
- I am a single woman and I work as a prostitute in the Darlinghurst area part time. I have no present address. I normally work on the corner of Farrell Avenue and Darlinghurst Roads, Darlinghurst.
- I heard this afternoon, after 4.30pm to 5.00pm 3. (30.4.85) that a transvestite named 'Wendy' had been murdered. I know the person 'Wendy' as he worked near me, but normally I'd see him sitting on his front verandah at Darlinghurst Road. During the day when I saw him he was normally dressed as a boy and in the night he was normally dressed as a woman. I never saw anyone else at his place apart from mates talking to him over the fence.
- About 1.00pm on Sunday 28 April, 1985, I was 4. walking in Ligerpool Street, Darlinghurst from Forbes Street direction towards Darlinghurst Road. I saw 'Wendy' in front of me and she was with a man. 'Wendy' was wearing a rusty colour dress which came just below his knees, a brwon cardigan and the dress had a floral design on it. When I got to about 4-5 feet behind them I heard that they were arguing and I heard him say "Christ!" and he waved his hands around in the air. He kept waving his hands and shrugging. I caught up to them and as I was next to the man he looked at me as I walked past.
- When I got to about 8-9 feet in front of them I looked back and I saw that they were still arguing. When I actually drew next to them they both stopped talking. I could hear that they were arguing but I couldn't hear what they were saying. I then walked into Darlinghurst Road and kept going I don't know if they followed me or not into Darlinghurst Road because I didn't bother to look back. I walked down as far as Farrell Avenue where I stopped and I still, didn't see them at 12 dutcheus On Signature:

- 6. I would describe the man who was arguing with 'Wendy' as being about 37-38 old, about 5'10" tall, of average build with the start of a tummy, he had very dark collar length hair that was straight, but very messed up, very messy, like he had gel in it, but I don't think he did. He had an olive complexion and to me he looked like a Yugoslav or similar. He had a thick growth on his face. He had a blue denim jacket on and black trousers. He was wearing black running shoes with grey strpies on the side - they may have been dirty white. He had really noticeable eyebrows, very thick and bushy and they joined up in the middle and bit thinner that the rest. He had a very broad nose.
- 7. Prior to seeing him with 'Wendy' I had seen him two or three times in the previous two or three weeks, On those occasions I had seen him in Darlinghurst Road, near Farrell Avenue. He had the denim jacket on every time I saw him.
- 8. I declare th t no part of this tatement is untrue to my knowledge. It accurately sets out the evidence which I would be prepared to give, if necessary, at Court as a witness.
