passenger side of the car. I asked her the price. I think the lowest price was \$30.00 for just straight sex. I think she went through all of the prices for different things but I said to just give me the lowest one. I can't remember the exact conversation.

(8) I got out of the car and followed her to a house that was a short distance down the road. We went inside the house and she took me to an upstairs bedroom. Once inside the room she asked for the money, I can't remember the exact conversation but she said "You've got to pay now " so I gave her \$20 or \$30, I can't remember.

(9) She did'nt fully strip just took off her pants and she told me to only take off my bottom half of clothing which I did and we had sex. I paid for this from money from my wellet, that's the last time I saw my wallet. Whilst having sex I placed my trousers on a chair, they were hanging over the chair. My wallet was in the back pocket.
