- q.1 NP181, can you tell me what you know about the murder of Wendy WAYNE, in Darlinghurst Road, last year?
- A. The other Transexuals because of the shock of Wendy's murder she was a real con, a theif and very sneaky, don't believe that she was aclean living person. As you probably know I lived in her flat before she took it over from me. I knew her from Les Girls back in the &70's and I didn't mix with her to much but towards the end I saw a fair bit of her.
- Q.2 In what way do you mean?
- A. I had the unit in Darlinghurst Road that I was using to work out of with and and I was leaving the unit and she wanted to take over it. Plus she wanted to buy a lot of the furniture I had in the unit. So I saw quite a bit of her while she was paying it off.
- Q.3 What do you know about her murder?
- New Zealand very close after Wendy's death. She never had any money and suddenly she had it. She went shopping and bought clothes and things like that. When I was in goal Danny SHAKESPEARE told me that he had been interviewed over the murder and that, that evening he had been with Wendy. [231] and another female prostitute named NP176.

 NP176 and some guy reportedly NP176 boyfriend whose surname name was He said that he hadn't told the police everything because he didn't want his wife to know that he had been involved with these Transexuals. He said that he had been at Wendy Wayne's flat the evening we she was murdered; at about 10 o'clock. Also present were the other people I mentioned above. He told me that, that he had told Police that after a coffee he had taken NP176 back up the Cross but in actual fact he had left her at Wendy's because there was some argument over a quantity of heroin, reportedly about \$15,000, street value worth, that NP176 had left in Wendy's house the previous day. It had gone missing. Wendy Wayne said that she hadn't wanted heroin in her place because wishe wasn't a 'Junkie' and she had told NP176 that she had flushed it down the lavatory.
- Q.4 This account given to by SHAKESPEARE is it the same account given to Police by him?
- A. I don't really know, anyway SHAKESPEARE mentioned that the NP176 had came through Neddy SMITH and he indicate to me that there was no doubt in his mind that Wared

Wendy had been murdered over the heroin but after I spoke to numerous other people and what I have heard a reasonable picture of what had happened came about between Wendy, [1231 and the heroin addict.

- Q.5 Who is 1231 ?
- A. I can't remember what her last name is but whe was Wendy's best friend.
- Q.6 Did SHAKESPEARE tell you exactly how Wendy was killed?
- A. No, he told me why he thought whe was killed and the people of course involved, which were these persons that I have mentioned.
- Q.7 Do you know anything about .
- A. No.
- Q.8 Do you know if Wendy was against drugs?
- A. I'm sure Wendy was against drug as far as her own use was concerned and comming across and amount worth \$15,000, she would sell it. She'd get | 1231 | to sell it.
- Q.9 Have you spoken to NP176
- A. Yes, I have not told NP176 I know anything at all about what happened. Each time NP176 lies and gives a different storey of what she thinks happened to Wendy.
- Q.10 How well did Wendy know NP176
- A. Pretty well I would say.
- Q.11 I have been informed that after your involvement in a trial concerning KELLEGHER, that you had to get away in a hurry because there were two lebonese 'heavies' after you. Do have anything to say about that?
- A. No, I haven't. If it was meantfor me, David knew where I was and he could have got me anytime.
- Q.12 Do you know of any Policeman keeping company with Wendy prior to her death?
- A. No, She didn't have one, I know that. She'd make it up.
- Q.13 Is there anything else you wish to tell me about this matter?
- A. | 1231 is the only one who knows, I'm sure she knows.
- Q.14 Is there anything to support your suspicions about 231 apart from what yourve told me?
