2. My full name is Neville Phillip Allan John PATCHING. I reside at 40 Freya Street, Kariila. I was born on the 19th of August, 1960. I reside with Michael and Marie at the above address, phone number 528 5991. I have resided there for about 4 months.

3. I have been employed by the Metropolitan Security Services for approximately 8 months. I employed as a static guard and engaged on those duties in various locations throughout the metropolitan area.

4. I know a person by the name of Wendy WAIN. I know her to be a transsexual as I met her at Pete's Bar about 2 years ago. I was a regular drinker at the bar at that time and Wendy was in the show at that time. I had a relationship with her mainly on the weekends for about 2 weeks after I first met her. his name. When I got home I did some training, had a shower, got changed, had something to eat, left home and came into town arriving here about 10pm. When I came into town I went straight to the 'Unicorn' Hotel in Oxford Street, Paddington. I stayed there till just before 12 midnight, whilst there I watched the show, they have a drag show there.

7. I left the Unicorn Hotel and went to Patches to wait for Vivian. Vivian arrived about 1.20am, I had a couple of drinks with her, she was a little pissed. We went into the other bar and talked for a couple of minutes, she started dozing off. We then left patches and went to Vivian's place in Davies Street. We arrived at her place about 3.30am. We dozed off on the lounge and woke up about 8.30am Sunday morning and went to bed.

8. I was asleep till about 2.30pm on Sunday afternoon and I went down stairs and I met an older man, I don't know his name I think he said he was from Queensland. Another man came around he was a little younger, I don't know his name. There was another drag there by the name of 'Shanon', she was there with her boyfriend. I stayed there until about 5pm Sunday afternoon. I then returned home to Karilla, I arrived home about 6pm. I had a talk to [REDACTED] and [REDACTED], then I got changed and did a bit of exercise.

9. About 7pm I had some dinner. When I watched T.V. I was pretty tired, I can't remember what I was watching, but I fell to sleep shortly after. [REDACTED] woke me up about 8.30pm, it wouldn't have been any later than 9.30pm. I cleaned my teeth and went to bed.

10. About 6am on Monday the 29th of April, 1985, [REDACTED] came in and woke me up and gave me a cup of tea. I left home about 7.30am and went to work at Darlinghurst Social Security in Oxford Street, Darlinghurst. I had lunch about 12.30pm and went to the bank, I had to get some money out. I then returned to work at the Social Security office. I finished work about 5.30pm. I then went to Terry Street, I think the number is [REDACTED], Drumoyne, where I did martial arts training with Lawrence LEE. I finished training about 7.30pm and went home to Karilla.

11. I am a Licensed Private Inquiry Agent, employed by M.S.S. I haven't got a pistol license. I receive a pistol from M.S.S. which I sing for. The pistol I receive is a Browning 32 mm, I get the



same one issued to me all the time. I signed the pistol in on <sup>N.P.</sup> Saturday the 27th of April, 1985, about 1.30am. I did not have the pistol over the weekend. I did not sign the pistol back out until Tuesday afternoon about 5.30pm. The serial number of the pistol that is issued to me is [REDACTED].

12. I have two tattoo's on my left upper arm is a Sailer bird. On my right upper arm is an Anchor and a Sailing ship with a sun and clouds.

13. I have no friends by the name of David and I have not any friends who work with the or in the Police Department. I do not privately own any firearm's whatsoever. As far as I know neither do [REDACTED] or [REDACTED], the people I live with.
