RECORD OF INTERVIEW BETWEEN DETECTIVE CONSTABLE 1/C P.H.SHORT AND DANNY ROBERT SHAKESPEARE AT THE MAROUBRA POLICE STATION ON SUNDAY, 5 JA UARY, 1986.

- O1. I am Detective SHORT and this Detective TRENCH we are from the Darlingburst Police Station. We are making enquires into the murder of a person named Wayne BRENNAN also known as Wendy WAYNE. I am going to ask you some questions in relation to the murder. My questions together with your ans wers will be recorded on the typewriter by Detective TR NCH in the form of a record of interview. Do you understand that?
- A Yes.
- 62. At the conclusion of the interview you will be given the opportunity of reading through the intervew and signing it. Do you understand that?
- A. Yes.
- 03. For the purpose of this record of interview What is your full name date of birth and address ?
- A. Danny Robert SHAKESPEARE. , 60. maroubra.
- Q4. Are you currently employed?
- A. No.
- On the 30th of a pril, 1985 the body of Wayne BRENNAN was found in a flat in Darlinghurst Rd, Darlinghurst. Did you know this person?
- A. Yeah.
- 06. Would you outline to me where you met BRENNAN and your knowledge of BRENNAN activity?
- A. I met her at Darlinghurst where she was working in the lane next to William Street.I met her through NP176.

 I drove down there with NP176 and she told me to stop and she introduced me to Wendy WAYNE. She started talig to Wendy then we went to the Coffee shop on the top of William Street. NP176 and Wendy started to argue about money so I left.
- 07. Erom your knowledge was Wendy WAYNE involved in any drug activities?
- A. From my knowledge she wasn't selling or using. But NP176 NP176 was using and selling.
- Q8. On how many occasions did you met Wendy WAYNE?
- A. I only met her to say hello to her when I seen her at the Cross.

Q9.	Did you know where Wendy WAYNE ,ived?
Α.	Yeah, she lived at D rlinghurst. I been there once it was a white coloured place I didn't go in there I dropped NP176 off there once. NP176 was staying there at that time.
Q10.	How dong ago was this?
A.	About 8 months or so ago. It would have geen a couple of weeks before Wendy was murdered.
911.	Would you outline to me your relationship with NP176 ?
A	NP176 lived with me at my Mothers address at , Maroubra.
Q12.	Do you have any knowlede of who murdered Wendy WAYNE?
A.	Yes. I was living with NP176 at Maroubra. I was questioned by Detectives over the murder of Wendy WAYNE I told NP176 that I was worried that I could be charged with it. She said no you can't be. I said, "Why is that". She said, "Because I know who the person involved was." I said, "C n you prove that to me or to anyone else?" She said, "Yes." She then got up and went into the bathroom where she stayed for some time about 10 minutes. She had a shot of heroin. When she returned from the bathroom my M, ther was sitting up having a ciggarrette. So NP176 went into the other room. I spoke to me mum for about 5 minutes. I then went back into the other room and sat with NP176. I asked her about it again. She told me towait until my mother had gone back to bed. After my mother went back to bed we began to talk about the murder. She told me she wanted to talk to somebody but she didn't say what for at that time. She then told me that she trusted me and to swear not to ever say anything to anyone about what she was about to tell me. Cause if I did we would both be dead. I told her that I would not say anything and that she should know that I won't say anything. She started to tell me about her friendshi with Wedny WAYNE and that she and NP176 were selling Heroin for a person who I did not know at that stage. She said that she was ba ging up to sell. Wendy WAYNE came home from doing a show whilst NP175 and another prostitute named [236] were doing the bagging of the dope. An argument started NP176 said she would get rid of it, she went out to ring up a prostitute that I knew named Chris. When she came back, [236 had gone and she thought that [236 had taken the dope with her . NP176 found lease the next day and S my told her that Wendy WAYNE had flushed it and told [1236 to get out or she would ring the Police. [236] no NP176 and [236] then went to find lendy WAYNE as [236] had rip ped her off. They found Vendy at the coffee shop where she was talking to another drag queen by the name of [231] They then went down the lane
they	NP176 walked down the lane with Wendy and 1231 where talked to Wendy on her own. That is when NP176 found out
oney	that 1236 hadn't ripped her off, that Wendy had flushed # it. NP176 told her that Wendy would have to pay he back the money which involved around five or six hundred dollars. Wendy said to NP176 that she wasn't going to pay her back and that she kwnew where the dope come from and who she was selling it for and if she didn't leave her alone and stall he sling her

she would drop them. NP176 told her that if she didn't pay her back she'd be off; NP176 seen her a couple oftimes after that, and she refused to do anything. NP176 told me she had no choice either Wendy copped it or she copped it. Then we had a coffee. She then went on to tell me how it happened. Can I go to the toilet.

 Q13. Would you tell me what knowledge you have of how Wendy WAYNE was murdered?
- Exactly how NP176 told. That same night at Maroubra she told me. She told me that her and a guy named Ian along with another bloke who's name I can't remember went to the Cross where they found out that Wendy was working in a lane. NP176 and the fellow named Ian went and wiated across the road from Wendy's place. A. The other fellow drove down the lane and acted as a customer and picked up Wendy. He took her back to her place where she did the \$100 and \$200 jobs. NP176 and the other fellow waited for 10 or 15 minutes after Wendy and the other person went inside. They then went across and NP176 said that she had a key to the door from when she was staying there. They went inside and the other fellow left. She then started to argue with her and she said that Wendy had nothing on. NP176 pushed her to the ground and the other guy named Ian supposedly shot her with a .22, I don't know if that is the right gun NP176 does'nt know about guns. NP176 then grabbed a few of her belongings so that none would know that she had been there. She then left and ther other guy remained at the flat because he was going to make sure that no one knew how or what she was shot with. They then met in the other persons car at the Gold Fish bowl outside on the corner.
 They then drove to the Art Museum and NP176 got rid of the stuff that she had picked up at Wendy's felt. Flat. She also told me that they got rid of the gun somewhere down there. She did'nt say what she did with it.
- Q14. Did she tell you anything else?
- A. Yeah they went back to that place I told you about in Darlinghurstwhere they were setting the dope from and the two men left. NP176 went to work.
- NP176 tell you who organized the murder? Q.15 Did
- Yeah, she told me that she was paid in smack and her A debts wiped out, by a bloke called Neddy SMITH.
- **NP176** Q.16 Do you know for what period of time lived with Wendy WAYNE?
- I could'nt exactly say, she told me she was living there when 9.17 I first met her, that was about 7 or 8 months ago, I'm not
- Q.18 Would you describe **NP176** to me?
- She's tall, medium build, long straight black hair, witha Chinese look, tattoos on her arms. She used to work the Cross on the corner of the pub just up the road from Wendy WAYNE's place. Like

- Q.19 In your answer to question 13 you referred to a person named Ian. Have you met this person before?
- A. Yeah once, I met him when he was talking to NP176 at the coffee shop up the cross. That was about two weeks before the murder. He said he come from Melbourne. I seen him at the Coffee shop near the lane where Wendy was picked up about 2 or 3 weeks ago.
- Q.20 Would you describe the person Ian to me?
- A. He's about 6 feet tall, dark short hair, moustache, tattoos on his left and right arm, pictures and then finishs off with a sleeve job. He's a bit above medium build. About 27 or 28 years old. He's Australian and got a suntan. He told me that he worked as a debt collector.
- Q.21 Do you now how NP176 came to met this person Ian?
- A. She said she'd known him for years. That's right he has gold on the end of two of his teeth.
- Q.22 Was Wendy WAYNEmurdered because to flushing the heroin?
- A. No, she knew too much above NP176 's association and activities and the people she was involved with.
- Q.23 Has NP176 spoken to you more than once about the murder?
- A. About three days after she spoke to me at Maroubra she told me to make sure I did'nt say anything.
- Q.24 Are you prepared to attend Court and give evidence in this matter?
- A. Yes.
- Q.25 Is there anything further that you want to say about this matter?
- A. No.
- Q.26 Will you now read this record of interview and sign it if it is correctly recorded?
- A. Yes.
