1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 56 years of age.

3. I am employed as a first aid officer with Patricks Australia Stevedore which is located at wharf 5, container terminal, Hickson Road, Darling Harbour. The first aid office is located on the ground floor at the 5 Darling Harbour building. On Sunday 2nd March 1997, I worked at terminal 8, Darling Harbour between the hours of 2pm and 7.45pm. On Monday 3rd March 1997, I commenced work at 6am at terminal 5, Darling Harbour.

4. About 7.45am on Monday 3rd March 1997, I was approached by Mr Jim Gould, mechanic with Patricks, in the first aid post at the terminal 5 building. He said to me, 'There is a guy laying down at 4 Darling Harbour, he looks bad.' I told him, 'Ring up the ambulance.' I then placed the oxygen bottle and the first aid kit in the company first aid vehicle. I followed another employee, Peter Cowen in his vehicle to the northern end of terminal 4 where I saw a man lying face down on the bitumen surface. The man was laying at the bottom of a rock cliff and very close to it. I parked my vehicle next to the body. I got

out of the car and put on my gloves. I walked over to the man and I touch him on the forehead to see if he was breathing. I noticed the right side of his face was badly injured and I saw a lot of blood on the ground next to the man. I then checked his pulse in his left hand. I could find no signs of breathing or a pulse. A short time later, an ambulance motor cycle officer arrived and examined the body. He could find no signs of life and we put a blanket over the body. I later saw uniform Police Officers and an ambulance arrive at the terminal.

5. When I first saw the body on the ground, ~~it was laying face~~ down, his right hand was up under his chest and his left hand was outstretched down the left side of his body with his palms up. Apart from checking his pulse and lifting his forehead slightly, I did not touch or move the body in any way. The man was wearing a blue jeans, running shoes and whitish coloured T shirt.
