> 1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 34.

3. I am a senior youth worker at the Mount Penang Juvenile Justice Centre. I have worked here for 8 years and I have a good relationship with the residents and on most occasions I talk reasonably freely with them.

4. About 9 months ago, I am not sure of the exact time or date, I was working at Mount Penang in the Walpole Unit. Between 4pm and 7pm I was walking through the bed area and I overheard a conversation between <u>NP131</u> and a small group of other detainees sitting around <u>NP131</u>'S bed.

5. The residents were discussing beating people up when I heard <u>NP131</u> state in words similar to, "Me and some mates were in a park chasing some white cunt to roll him." I said, "What park was that?" He said, "Some fucking park down near The Rocks. We bailed him up near a fence that he was trying to climb and we hit him over the head with a fucking bottle.

Blood starting pissing out everywhere and we shit ourselves and threw the cunt off a cliff near some bushes and fucked off.

6. I looked up in disbelief as the story was a bit out of the norm for the residents. NP131 looked at me and started laughing and replied, "Nah, I'm just talking shit. You would believe anything I would tell you."

7. I then continued on with my normal shift and didn't think much more of the story as I believed that <u>NP131</u> had made it up, as the residents are always making up stories to big note themselves about crime, to impress the other residents.

8. On Monday night 24th November, 1997 I was watching the Australia's Most Wanted program when I saw a story on the Scott MILLER death and how he died in The Rocks area. I thought it was extremely coincidental about the way Scott MILLER died and the story from NP131 9 months ago, so I called Crime Stoppers and reported what NP131 had told me.

9. On 26th November, 1997 I spoke to Senior Constable LANE at Mount Penang and made this statement. The version of what <u>NP131</u> said in his story is to the best of my memory. The conversation took place about 9 months ago so I can't remember all the exact words or how the conversation started but the version in the statement is pretty close to what he said.
