The items were returned to the Unsolved Homicide Team Offices. P377 Forms were completed.

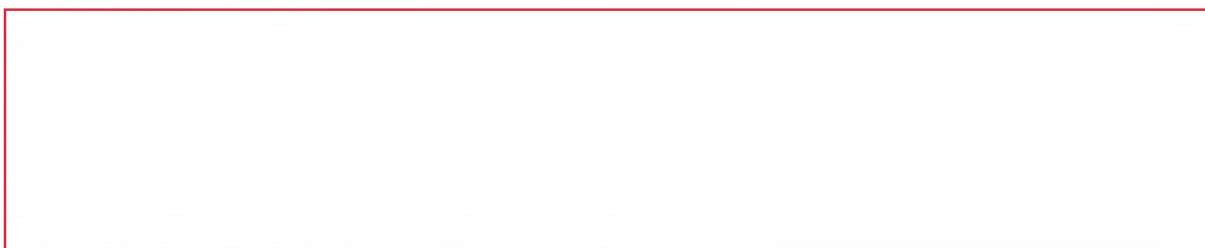
On 10 March 2010 the items were then conveyed by DSC Tamer KILANI to the Division of Analytical Laboratories at Lidcombe.

On Monday 3 March 1997 the deceased was located at the Patrick Container Terminal, Millers Point Sydney. The body was found under a 10 metre cliff. The Coroner found the deceased suffered multiple injuries caused by a person or persons unknown. Investigators did not agree with this finding. They were of the view the deceased had accidentally fallen to his death while climbing over a security fence.

The exhibits are submitted with the objective of identifying any trace DNA on the items, signs of a struggle which may be evident from damage or stretch marks to any of the items.

Items three and four are blood stained. This blood is believed to have originated from the deceased.
