1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 33 years.

3. I am a full time student studying Manufacturing Engineering at the University of Technology, Broadway, Sydney.

4. On Tuesday the 7th of March, 1995, I attended the university between 1.00pm and 8.00pm for my class.

5. At the conclusion of my class, I walked to the Northcott Block of Flats in Belvoir Street, Surry Hills. I think I arrived there about 8.15pm as it takes me about fifteen minutes to walk there from the University. I walked into the main foyer of Block and was waiting for the lift. While I was waiting, a man walked in and stood behind me. He was by himself. The lift arrived, I walked in to it and the man standing behind me entered the lift also. I saw that he had two dogs with him. One was a small black dog and the I can't remember the other one, only that it was small. I pushed the lift button for the 12th floor. There was no conversation between us in the lift, but I knew he was going to the 12th

floor as I have seen him on the 12th floor on a number of previous occasions when I have been visiting my close friend, Gloria ARANGO. She lives in on the 12th floor. I have never spoken to him and do not know which unit he lives in.

When the lift arrived on the 12th floor, I stepped out and 6. turned to the right and I saw that he stepped out and turned to the left and walked towards the corridor. I then went to my friend's unit and did not see him again.

About 4.30pm on Sunday the 12th of March, 1995, I was 7. with my friend, Gloria ARANGO at her unit when a Detective spoke to her. He then spoke to me. Later that same afternoon I attended the Surry Hills Police Station where I spoke to Detective Sergeant KASSIS and Detective MILLIGAN. I was then shown a colour photograph of a man. I am positive that the man depicted in the photograph is the same that I entered the lift with as I have described.

On Tuesday the 7th of March, 1995, when I caught the lift 8. with this man, I am unable to remember if he had any injuries to his face or head. I remember that he was wearing glasses with clear lenses and silver frames. I think he was wearing a grey coloured T shirt and long pants but I can't remember the colour. He did not speak to me and I did not speak to him. I did not see any other person in the foyer or on the 12th floor. Also no other person entered the lift.
