1. This statement made by me accurately sets out the evidence which I would be prepared, if necessary, to give in court as a witness. The statement is true to the best of my knowledge and belief and I make it knowing that, if it is tendered in evidence, I shall be liable to prosecution if I have wilfully stated in it anything which I know to be false or do not believe to be true.

2. My age is 39 years.

3. I am currently a resident of Northcott Flats at Surry Hills. I have been living here for the past 2.5 years. In that time I met a man who I know as Jimmy MEEK. I met Jimmy about a year and a half ago. Jimmy lived on the 12 floor of the Morthcott Flats. I met Jimmy when I was walking my dog in the park next to Northcott flats, where Jimmy used to walk his dog everyday.

4. I became a good friend of Jimmy's because I used to see him most day or every second day when he was walking in the park with his dog. Jimmy also used to hang out alot with **NP219** **NP219** who lives on the **[REDACTED]** floor of block **[REDACTED]** and I use to speak with him abit when I saw them together. Occasionally I would go up to Jimmy's flat and have a coffee.

5. When I met up with Jimmy we would often talk about alot of things in general, he told me that he was a homosexual and had aids and that he used to be a security guard and got shot. I

knew that Jimmy used to hang out alot with a guy I know as 'Bob' who would go to Jimmy's house alot and stay. They were good friends and had known each other for a long time. This guy 'Bob' used to live in the suburbs somewhere. I used to see Jimmy with alot of other men, but I never really payed much attention to them.

6. When Jimmy had problems at the flats he would often tell me about it when we met in the park. He told me about the time I think about two years ago when his friend [REDACTED] NP219, who is [REDACTED], got really mad at him in relation to his T.V. and his pet dog 'snooky'. I know that [REDACTED] NP219 often drinks and mixes pills and when she does this she gets very violent. Jimmy said that on this occasion she was really drunk and was really angry and that she grabbed Jimmy and held him over the balcony on the 12th floor and was only hanging on to him by his ankles. He said that after that incident he tried to keep away from her because she would often come up to his door and try and bash it when she was drunk and on the pills. I think Jimmy was a little bit scared of her.

7. I also remember the time when Jimmy was walking in the park with his dog, in late 1993 or early 1994, and I could see him from my bedroom window. I saw this tall young guy start to push Jimmy and fight with him. I saw that Jimmy was trying to walk away and the other guy walked after him and punched him to the ground. I had a busted leg at the time and walked down to the park to try and help. By the time I got there the guy had gone and I spoke with Jimmy at his unit. Jimmy had a few cuts on his face and he told me he was going to ring the police. Later, I was able to help identify the guy to Police. I knew his face because he had been living with Jimmy for a while. I think his name was 'Jason' and I had to later go to court as a witness when this 'Jason' guy was charged.



8. I cant really recall anything else that happened to Jimmy and after I went to court for his bashing matter we did not see as much of each other. He seemed to keep to himself a little more. I cannot really recall anyone person that Jimmy was seeing or sleeping with except for one time about April last year, Jimmy told me that he had two young guys staying with him. He did not tell me much about them and I never met them. I only saw them once and I can only describe them as 17-18 old. One guy was quite tall and the other fellow was shorter. Jimmy told me that he was going to kick these two guys out of the house as they had been stealing money and stuff and that he had had enough of them. He didnt say anything else about them.

9. I cannot really say anything else about Jimmy. In April, 1995 I spoke with Detective TONNET and later made this statement.
